# **Nature Agreements: Mindstate builders**


Within the Mind, what is a Nature Agreement?


According to a Geometrical Thought Harmonics concept, Nature is an Attitudinal expression of Emotional Intelligence, which is an Attitudinal expression of Feeling. Feeling Suggests Behaviour. Therefore, Nature is Attitudinal Behaviour. As a mainstream definition, this sounds quite acceptable. In context, a Nature Agreement would be an Agreement of Attitudinal Behaviour.

In Geometrical Thought Harmonics, a Square represents Intellect, which takes on board and builds upon concepts. A centre-point Hexagon represents Awareness, which is a Love-based Sense Agreement. Sense is represented as focused Equilateral Triangles that form a Pyramid. An Equilateral Triangle represents Creative Thought or Imagination. Therefore, Sense is focused Creative Thought or focused Imagination. In relation to a centre-point Hexagon, it is formed by six Equilateral Triangles connected to or forming a centre-point. The Equilateral Triangles are focused to form a planar Pyramid. The edges of the Equilateral Triangles form diagonals of the Hexagon, which becomes an Agreement. A Hexagon represents Love, which is unconditional acceptance. It also represents reflex responsive, programmed, or impulsive Thought. Therefore, Awareness is a reflex responsive, programmed, or impulsive Sense Agreement. Mind is an accumulation and categorisation of Thoughts, which is Memory. It is a Logical construct initiated or Suggested by Feeling, which is Behaviour. Logic is a Library Of Growing Intelligent Concepts. Therefore, Mind is Behavioural Logic or Memory of Behaviour.

Within the Mind, and in relation to Geometrical Thought Harmonics, an Agreement is represented by a central intersection of Lines of Thought. It forms a Polygonal Trait with a centre-point e.g. two intersecting lines forming the diagonals of a Square, three intersecting lines forming the diagonals of a Hexagon, five intersecting lines forming the diagonals of a Decagon etc.

A Nature Agreement is a product of Octahedrons of Nature whereby the edges of the Octahedrons intersect to form polar Polygonal Traits with a centre-point. Examples are shown below. The picture below left shows two Octahedrons of Nature forming an Intellect-polarised Nature Agreement. It forms the diagonals of a Square of Intellect at the top and bottom of this structure. The picture below right shows a Cube of Common Logic, a product of two Tetrahedron Pyramids forming an Agreement, which is formed by the intersections of the Octahedron edges. A Tetrahedron Pyramid represents Common Sense. Two Tetrahedron Pyramids forming a Cube creates a Common Sense Agreement because the intersecting edges of the Tetrahedron Pyramids form six centre-point Square planes of Intellect. Therefore, this Nature Agreement forms a Common Logic Mindstate. The Cube of Common Logic represents the Memory of Attitudinal Behaviour. The centre-dissecting Square Emotional planes that form the polar centre-point Squares form an Intellect-polarised Emotional Intellect







Agreement, which is unbiased Emotional Logic. By unbiased, we mean that the polar planes are the same as the centre-dissecting planes of this structure. They are Squares of Intellect.


The next Nature Agreement is formed by three Octahedrons of Nature with polar centre-point Hexagon Traits of Awareness. It becomes an Awareness-polarised Nature Agreement. The three centre-dissecting Square Emotional planes that form the polar centre-point Hexagons create an Awareness-polarised Emotional Intellect Agreement, which is Awareness-polarised Emotional Logic. This Awarenesspolarised Emotional Logic becomes a state of Mind called Tolerance. Therefore, this Nature Agreement is a Tolerant Nature Agreement.


The picture below left shows three Octahedrons of Nature forming a Tolerant Nature Agreement. The picture below right shows two Logic states that are formed by the intersecting edges of the Octahedrons of Nature. One is a Hexagon-polarised Prism of Love Logic. If it is a centre-point Hexagon it becomes Awareness Logic. The other is two overlapping Equilateral Triangle-polarised Prisms forming Hexagram poles. An Equilateral Triangle-polarised Prism represents Creative Logic and two overlapping Creative Logic Prisms becomes Experiential Creative Logic. It also shows the three centre-dissecting Square Emotional planes that create the Awareness-polarised Emotional Intellect Agreement of Tolerance.






The picture below left shows a Prism of Awareness Logic, which is 6 Creative Logic Prisms connecting to form polar centre-point Hexagons of Awareness. This becomes a Love-based Creative Logic Agreement because a Hexagon represents Love, which is Reflex responsive, programmed, and Impulsive Thought. In essence, it is the unconditional acceptance of Love that develops Reflexes, programs, and impulses. The picture below right shows one of the Creative Logic Prisms.





The picture below left shows the Awareness-polarised Emotional Intellect Agreement of Tolerance. The picture below right shows Experiential Creative Logic, which is two overlapping Creative Logic Prisms that form polar Hexagrams. Overlapping Polygons represent Interaction, which is experiential.



This principle of creating Prisms within these Nature Agreements by adding points to the intersections of the Octahedron edges is universal. My reasoning behind this statement is that if we take any even numbered Polygon and then use it to create a Prism with Square sides, it will create other Prisms within it by connecting every second point, third point and so on e.g. connecting every second point of a Hexagon creates two overlapping Equilateral Triangles, which you then turn into Square sided Equilateral Triangle Prisms. If we connect every third point of the Hexagon, it creates three centre-dissecting Square planes. It doesn't create any more divisions.

By adding Octahedrons that are sitting on Cuboctahedral axes so they form polar polygonal planes, the intersections of the Octahedron edges will always create all of the other Prisms related to its polygonal structure e.g. an Intellect-polarised Nature Agreement forms a Cube of Common Logic. An Awareness-polarised Nature Agreement forms two overlapping Equilateral Triangle Prisms and a Hexagon Prism. A Belief-polarised Nature Agreement forms four Prisms. The first is a Decagon Prism. Next would be two overlapping Pentagon Prisms. The third would be a Decagram Prism with every third point connected. The fourth would be two overlapping Pentagrams by connecting every fourth point. Every fifth point would create the Belief-polarised Emotional Intellect Agreement. Therefore, it would form five Logic states.


In Geometrical Thought Harmonics, polar diagonal edges formed by centre-dissecting Squares of Intellect form Polarised Emotional Intellect Agreements of Emotional Logic. Overlapping polygons form experiential forms of those initial polygonal Traits. True Grammic forms that connect all the points of the Polygon with one continuous internal line connection are Mental Traits that form Interpretations of the initial polygonal Trait e.g. a Pentagram gives an Interpretation of Motive, Personal Thought, or Consciousness. A Decagram gives an Interpretation of Belief or Choice. An Octagram gives an Interpretation of Morality. A Hexagram does not create one continuous line connection. It creates two separate Equilateral Triangles. As Prisms, it would become experiential Creative Logic. Creative Logic would be a Practical Logic, not a Mental or Interpretative Logic.


A construct of Mind has Agreements, and then it has Diversions to the Agreements. In relation to a Nature Agreement, the Emotional Intellect Agreement or Emotional Logic Agreement is the former. The

other Logic states become Diversions to the Agreement. Why is this statement important? As previously explained, Logic states are formed by the intersections of the Octahedron edges that form the Nature Agreement. In essence, it is an Attitudinal expression of Emotional Logic. The Points that form the Logic states create divisions on the Square-based Pyramid edges. Therefore, they are sequentially expressed by Attitude. This means that from Emotional Logic, which is the Agreement in question, in the process of the Emotional Logic being expressed by Attitude to become Nature, the other Logic states become Diversions to the Agreement. It is progressively Diverted through those Logic states e.g. in the case of a Tolerant Nature Agreement the Emotional Logic or Awareness Logic before it becomes Nature, which is Attitudinal Behaviour. Therefore, Attitudinal Behaviour is Suggested by Tolerance and then Practically Applied through Experientially programmed Creative Logic and Love Logic, or Awareness Logic, which are all forms of Reflex Responsive, Programmed, and Impulsive Memory. Awareness Logic is a Love-based Creative Logic Agreement.


The next Nature Agreement is a product of five Octahedrons of Nature that forms polar Decagon planes with 5 centre-dissecting Squares of Intellect. It becomes an Affirmative Nature Agreement because of its internal Belief-polarised Emotional Intellect Agreement of Affirmation. This Nature Agreement is a product of Consciousness due to its Motive, Personal Thought, or Conscious base.


The picture below left shows the 5 Octahedrons of Nature that form the Affirmative Nature Agreement. The picture below right shows 5 Logic states within the Nature Agreement that are formed by the intersections of the Octahedron edges. The first is a Decagon Prism of Practical Belief Logic Applications. The second is two overlapping Pentagon Prisms of Practical Motive Logic Applications, which becomes experiential Motive Logic. The third is a Decagram Prism, which becomes a Mental Belief Logic Interpretation. The fourth is two overlapping Pentagram Prisms, which become experiential Mental Motive Logic Interpretations. The fifth is 5 centre-dissecting Emotional Square planes of Intellect that form the Emotional Logic Agreement of Affirmation.






The picture below left shows the Decagon Prism of Practical Belief Logic Application. The picture below right shows two overlapping Pentagon Prisms of Practical Motive Logic Application that forms experiential Motive Logic.







The picture below shows the Belief-polarised Emotional Intellect Agreement of Affirmation.




We have already concluded that Nature is an Attitudinal expression of Feeling, which becomes Attitudinal Behaviour. Attitude is represented by a Square-based Pyramid. It is an Intellect-based Sense, the position a Body takes in relation to an environment. Therefore, a Nature Agreement is an Agreement of Attitudinal Behaviour that can be polarised by certain Traits e.g. it can be polarised by fundamentals such as a Square of Intellect, a centre-point Hexagon of Awareness, a Decagon of Belief, and a Tetradecagon of Hindsight etc. Then it can have multiples of those fundamentals e.g. an Octagon of Morality, a Dodecagon of Synchronicity, an Icosagon of Identity, and an Icosikaioctagon of Foresight etc. The next Nature Agreement is Hindsight-polarised. Hindsight is a product of experiential Perception. As Perception is the way we see things, and a form of understanding, Hindsight is an understanding of how and why things happened in the past.

The picture below left shows 7 Octahedrons of Nature forming a Hindsight-polarised Nature Agreement, which is a Probability Nature Agreement. The picture below right shows 7 Logic states created by the intersections of the Octahedron edges. The outermost Logic state is represented by a Tetradecagon-polarised Prism, which is a Hindsight-polarised Practical Logic Application. The next is two overlapping Heptagon-polarised Prisms, which represents experiential Perception-polarised Practical Logic Applications. Then we have a Tetradecagram-polarised Prism connecting every three points, which is a Hindsight-polarised Mental Logic Interpretation. Next, we have two overlapping Heptagram-polarised Prisms connecting every four points, which represents experiential Perception-polarised Mental Logic Interpretations. Then we have a Tetradecagram-polarised Prism connecting every five points, which represents experiential Perception-polarised Mental Logic Interpretations. Then we have a Tetradecagram-polarised Prism connecting every five points, which represents a Hindsight-polarised Mental Logic Interpretation. Next we have two overlapping Heptagram-polarised Prisms connecting every six points, which represents experiential Perception-polarised Mental Logic Interpretations. The final Logic state is a Tetradecagon-polarised Emotional Intellect Agreement, which is Hindsight-polarised Emotional Logic. This is the Emotional Logic of Probability.







The picture below left shows the Tetradecagon Prism of Practical Hindsight Logic Application. The picture below right shows two overlapping Heptagon prisms of Practical Perceptive Logic Application, which is experiential Perceptive Logic. It connects every two points of the Tetradecagon.






The picture below left shows a Tetradecagram Prism of Mental Hindsight Logic Interpretation that connects every three points of the Tetradecagon to create Square facets. The picture below right shows two overlapping Heptagram Prisms of Mental Perceptive Logic Interpretation, which is experiential Perceptive Logic Interpretation. It connects every four points of the Tetradecagon.






The picture below left shows a Tetradecagram Prism of Mental Hindsight Logic Interpretation that connects every 5 points of the Tetradecagon. The picture below right shows two overlapping Heptagram Prisms of Experiential Mental Perceptive Logic Interpretations that connects every 6 points of the Tetradecagon.




The picture below shows a Hindsight-polarised Emotional Intellect Agreement of Probability that connects every 7 points of the Tetradecagon to create Square centre-dissecting planes of Intellect.





If we add the Feeling states that coincide with the Emotional Logic of these Nature Agreements, or Behavioural Agreements, the Intellect-polarised Emotional Intellect Agreement is expressed by the Attitudinal Behaviour of Nature, the Awareness-polarised Emotional Intellect Agreement of Tolerance is expressed by the Awareness-based Behaviour of Respect, the Belief-polarised Emotional Intellect Agreement of Affirmation is expressed by the Belief-based Behaviour of Trust, and the Hindsightpolarised Emotional Intellect Agreement of Probability is expressed by the Hindsight-based Behaviour of Retrospection.


Therefore, a Common Logic Mind is the Behavioural Logic of Nature. An Awareness Mind is the

Behavioural Logic of Respect. A Belief Mind, which is a product of experiential Motive, Personal Thought, or Consciousness, is the Behavioural Logic of Trust. A Hindsight Mind is the Behavioural Logic of Retrospection, and a Foresight Mind is the Behavioural Logic of Premonition. The Cube of Common Logic formed by the intersections of the Octahedrons edges that form the Agreement is expressed by Square-based Pyramids of Attitude. Each Square facet of the Cube is the base of a Square-based Pyramid of Attitude. Therefore, Common Logic is Attitudinally expressed. The Square sides of each of the Prisms formed within all of the Nature Agreements have Square-based Pyramids attached. Therefore, all of the Logic states that form a Mindstate are expressed by Attitude. If we look closely at the images ahead we can see the edges of the Square-based Pyramids attached to the Square sides of each Prism or Logic state. The Cube is expressed on all sides because it is not a form of polarised Logic. It is unbiased. All forms of polarised Logic are biased by polar Polygonal designs of Thought e.g. Hexagon-polarised Prisms are Love or Awareness-polarised, Decagon-polarised Prisms are Belief-polarised, and Tetradecagon-polarised Prisms are Hindsight-polarised etc.









In some circles, Probability has been likened to Possibility. However, Possibility is Potential. Probability, or Predictability, is the likelihood of that Potential to manifest. That likelihood is determined by responses to circumstances and conditions, both present and previous.


Hindsight is a product of Perception, which is the way we see things. Perception is a form of understanding. Hindsight gives an understanding of why and how things eventuated. It is experiential or experience-based Perception.


Foresight is a product of Hindsight. To more accurately predict the Future, we must take note of how and why things happened in the past. However, to more accurately predict Future events, the circumstances and conditions of the past would need to remain the same. Therefore, due to constantly changing circumstances and conditions, those predictions would be subject to environmental and response-based variables. However, if a common Mindset was still in play, predicting outcomes based upon that Mindset could be quite accurate. In simplicity, Foresight is a product of Perceptive Intelligence.

What is Foresight-based Behaviour? It would be Premonition, which is a Feeling that something is going to happen. Behaviour is Suggested by Feeling.


What is a Foresight-polarised Emotional Intellect Agreement? It could be Prediction, which quite often relies upon information acquired. In essence, it is an Agreement of what could occur in the future and relies upon Hindsight for its Prediction. A better word might be Extrapolation, which is a prediction based upon what is known.

The picture below left shows the Extrapolation Nature Agreement and the Foresight-based Nature of Premonition. The picture below right shows the Foresight-polarised Emotional Intellect Agreement of Extrapolation and 13 other Logic states within the Extrapolation Nature Agreement. It also shows Foresight-based Feeling within the Foresight-based Nature of Premonition. Foresight-based Nature is Attitudinally expressed Feeling or Attitudinal Behaviour. Therefore, the Foresight-polarised Emotional Intellect Agreement of Extrapolation is expressed by the Foresight-based Attitudinal Behaviour of Premonition. It is Premonitory Extrapolation.







A Foresight Mind has 14 Logic states. The innermost is a Icosikaioctagon Prism of Foresight-polarised Practical Logic Application that connects every point of the 28 point structure. The second is 2 overlapping Tetrakaioctagon Prisms of experiential Hindsight-polarised Practical Logic Application that connects every 2 points. The third is a Icosikaioctagram Prism of Foresight-polarised Mental Logic Interpretation that connects every 3 points. The fourth is 4 overlapping Heptagon Prisms of experiential Perception-polarised Practical Logic Application that connects every 4 points. The fifth is a Icosikaioctagram Prism of Foresight-polarised Mental Logic Interpretation that connects every 5 points. The sixth is 2 overlapping Tetrakaioctagram Prisms of experiential Hindsight-polarised Mental Logic Interpretation that connects every 6 points. The seventh is 7 overlapping Cubes of experiential Common Logic that connects every 7 points. The eighth is 4 overlapping Heptagram Prisms of experiential Perception-polarised Mental Logic Interpretation. The ninth is a Icosikaioctagram Prism of Foresightpolarised Mental Logic Interpretation that connects every 9 points. The tenth is 2 overlapping Tetrakaioctagram Prisms of experiential Hindsight-polarised Mental Logic Interpretation that connects every 10 points. The eleventh is a Icosikaioctagram Prism of Foresight-polarised Mental Logic Interpretation that connects every 11 points. The twelfth is 4 overlapping Heptagram Prisms of experiential Perception-polarised Mental Logic Interpretation that connects every 12 points. The thirteenth is a Icosikaioctagram Prism of Foresight-polarised Mental Logic Interpretation that connects every 13 point. Last, is the Foresight-polarised Emotional Intellect Agreement of Extrapolation that connects every 14 points, which forms the diagonals of the Icosikaioctagon of Foresight. The picture below left shows the Icosikaioctagon Prism, which is a Foresight-polarised Practical Logic Application. The picture below centre shows two overlapping Hindsight-polarised Practical Logic Interpretations, which are experiential. The picture below right shows the Foresight-polarised Mental Logic Interpretation connecting every three points of the Icosikaioctagon Prism.





The picture below left shows 4 overlapping Practical Perceptive Logic Applications, which are experiential. The picture below centre shows the Foresight-polarised Mental Logic Interpretations connecting every five points of the Icosikaioctagon Prism. The picture below right shows two overlapping Hindsight-polarised Mental Logic Interpretations connecting every 6 points of the Icosikaioctagon Prism, which are experiential.



The picture below left shows 7 overlapping Cubes of Common Logic creating Foresight-polarised experiential Common Logic. The picture below centre shows 4 overlapping Perception-polarised Mental Logic Interpretations connecting every 8 points of the Icosikaioctagon Prism, which are experiential. The picture below right shows Foresight-polarised Mental Logic Interpretations connecting every 9 points of the Icosikaioctagon Prism.











The picture below shows the Foresight-polarised Emotional Intellect Agreement of Extrapolation.





A Harmony Nature Agreement is a product of two overlapping Tolerant Nature Agreements, which become experiential. Harmony is Mutual Tolerance, which is a Synchronicity-polarised Emotional Intellect Agreement or Synchronised Emotional Logic. Synchronicity is represented as a Dodecagon, which is a product of three overlapping Squares of Intellect, four overlapping Equilateral Triangles of Imagination, and two overlapping Hexagons of Love. If the Hexagons have a centre-point or Agreement, they are centre-point Hexagons of Awareness. Therefore, Synchronicity is experiential. It is Creative Intelligence, Intelligent Creativity, and Reflex Responsive or Impulsive Intelligence and Creativity. This becomes a Coordinative Impulse of experiential Awareness.


In essence, a Harmony Nature Agreement is also a product of three Intellect-polarised Emotional Intellect Agreements, which are unbiased.

# **Progressive Nature Agreements**


If we combine 3 Intellect-polarised Nature Agreements with Octahedral axes, it creates the Moral-based Attitudinal expression of Self-awareness called Self-control. Moral-based Attitudinal Behaviour is Virtue. Therefore, Self-control is Virtuous Self-awareness. The picture below left shows the 3 Intellect-polarised Nature Agreements that create Self-control. They share the same Cubic Common Logic core as shown by the picture in the centre. The picture below right shows the Cuboctahedron of Self-awareness that is created by the combination of those Nature Agreements. Self-awareness is a product of Emotional Awareness that is impressed by Attitude and Common Sense, which creates Attitudinal Awareness and Common Sensory Awareness. It is also a product of unbiased Emotional Logic, which is an Intellect-polarised Emotional Intellect Agreement.









If we combine 4 Tolerant Nature Agreements with Cubic axes, it creates Passion Respect. Passion is a product of Emotional Awareness. It is a Love for what we do. Respect is Awareness-based Feeling that Suggests Awareness-based Behaviour. Passion Respect is Respect for what we do. The picture below left shows the combination of 4 Tolerant Nature Agreements. The picture in the centre shows the faceted structure of Passion that is created from the combination of the Nature Agreements. The picture below right shows the faceted sphere of the entire structure.









Affirmative Nature Agreements are products of Consciousness. Determining which axis to use in their combination can be a bit confusing. The Intellect-polarised Nature Agreement used the Octahedral axis. The Tolerant Nature Agreement used the Cubic axis. The Hindsight and Foresight-polarised Nature Agreements could use the Cuboctahedral axis, which may or may not be the correct axis to use. Initially, a Nature Agreement creates polar points in the centre of the intersecting Octahedron edges. Normally, those points would be Cuboctahedron points because when we divide the Octahedron edges in two and add points to those divisions, it would form the twelve points of a Cuboctahedron. Therefore, it is possible that when we create multiples of those Nature Agreements we should use the Cuboctahedron axis, which would have six polar point axes. Therefore, we would combine six Nature Agreements to form a sphere of Thought based upon the particular Nature Agreement used. The outcomes would be quite different to the ones I have shown. Therefore, I will show what happens when we use the Cuboctahedral axes for multiple combinations.


The picture below left shows 6 Intellect-polarised Nature Agreements combined in the Cuboctahedral axes. The picture below right shows the 3 Cubes of Common Logic created within the 6 Intellect-polarised Nature Agreements. The Cubic edges overlap to form Square Agreements of Intellect. Therefore, it forms Common Logic Agreements. The Intellect-polarised Emotional Intellect Agreements are not shown.






The picture below left shows 4 Cuboctahedrons of Self-awareness formed by the points of the 6 Intellectpolarised Nature Agreements. The Cuboctahedrons of Self-awareness become experiential due to the overlapping Square facets of the Cuboctahedrons forming Octagons of Morality. The picture below right shows the faceted sphere of the 6 Intellect-polarised Nature Agreements.


This structure also forms Moral-based Nature, which is Virtue. The Moral-polarised Cuboctahedrons of Self-awareness form Charity-awareness Nature Agreements. Charity is a Moral-polarised Emotional Intellect Agreement, which is Moral-polarised Emotional Logic. Therefore, this structure becomes a product of Charitable Self-control, which is a Moral-based Attitudinal Expression of Charitable Self-awareness.....a Virtuous expression of Charitable Self-awareness.







As we can see, the way we form multiple Nature Agreements makes a difference to the outcomes according to the axis of symmetry used in that formation.


Next, we form a multiple of 6 Tolerant Nature Agreements in the Cuboctahedral axes. They are Respectexpressed Tolerant Nature Agreements. The picture below left shows the 6 Tolerant Nature Agreements in the Cuboctahedral axis of symmetry. The picture below right shows the internal Hexagon Prisms of Love Logic and the experiential Creative Logic Prisms created within the Tolerant Nature Agreements. The Awareness-polarised Emotional Intellect Agreements are not shown.






The picture below left shows the Cuboctahedron of Self-awareness created from the points of the 6 Tolerant Nature Agreements. It forms the structure of Self-control within it, which is an Attitudinal expression of the Emotional Logic of Self-awareness. 






What has any of this to do with us? Geometrical Thought Harmonics is a way to understand the Mind through Geometries of Thought, which is Energy by design. What does this mean? Thought is Energy. Mind is an accumulation and categorisation of Thoughts. Designs of Thought are Traits of Mind or purposed Energy. Pure Potential is unpurposed or Pure Energy, which is Thought in general or the Potential of Thinking. Designs of Thought are the results of Thinking.


Nature Agreements are Agreements of Attitudinal behaviour. Why are Agreements of Attitudinal Behaviour important?

Attitude is the position a Body takes in relation to an environment. It is a Receptive and Constructive Sense. How we Feel about an environment Suggests how we will Behave within that environment. If there were numerous Personalities or Entities within an environment, and each of them Felt a certain way about that environment according to their personal preferences, there could be extremely contrasting Behaviours that might not be cordial. Therefore, Agreements are essential for stability of an environment. Are Agreements of Attitudinal Behaviour Consciously formed by Personalities? Or, are they unconsciously formed in relation to a particular or Common Mindset?


A state of Mind is simply a condition of Mind. A Mindset is a fixed way of Thinking. A Personality is an Identified Attitudinal Behaviour of Mind. Identity is a product of Belief, which is experience-based Motive, Personal Thought, or Consciousness, and a product of Intelligence, which is Receptive and Constructive Thought. It is Intelligent Preferentiality, or Preferential Intelligence.

Intellect takes on board and builds upon concepts. Belief is a declaration of Personal preferences or Choices. Identity is an accumulation of declared Personal Preferences, Beliefs, or Choices. Therefore, Personality is the position a Body takes in relation to an accumulation of declared Personal Preferences, Beliefs, or Choices that have been Suggestively taken on board and built upon through Trust. Evolvability is the ability of an entity to evolve. In Geometrical Thought Harmonics, Evolvability is represented as an Identity-polarised Emotional Intellect Agreement. Therefore, it is an Agreement of the declared Personal Preferences, Beliefs, or Choices that have been Suggestively taken on board and built upon. In general, that Agreement is usually expressed through Personality. It becomes Personalityexpressed Evolvability, which is the ability of a Personality to Evolve. The 10 Logic states within Personality-expressed Evolvability Nature Agreements form an Evolvable Conscious Mind. The picture below left shows the 6 Evolvability Nature Agreements in the Cuboctahedral axes. The picture below right shows 4 Cuboctahedrons of Self-awareness created by the 6 Evolvability Nature Agreements. Those 4 Cuboctahedrons are a product of three Virtuous Charity-awareness Nature Agreements formed by the 6 Evolvability Nature Agreements.






The picture below shows the faceted sphere of the 6 Evolvability Nature Agreements.

















## **Exposé of Agreements**

In Geometrical Thought Harmonics, what are the different types of Agreement? As previously stated, an Agreement is depicted as a central intersection of lines of Thought. This means that two or more lines intersect at the centre of each line creating a point of Agreement at that intersection. Using three-dimensional Geometry, as in Polyhedrons, if we connect two Tetrahedron Pyramids to form an Agreement, it forms a Common Sense Agreement.

A Tetrahedron is a Pyramid with four Equilateral Triangle facets, which represent the Creative Thought of Imagination. It is purely Creative on the Physical level as there are only external facets or planes, which means that the facets represent Physical/Experimental/Practical planes of Thought. When two Tetrahedrons of Common Sense form an Agreement, it becomes a Cube of Common Sensory Logic. This is an Agreement of Physical Creation as the lines forming the Agreement are the edges of the Equilateral

Triangles. However, when they are in Agreement, the Equilateral Triangle facets become Mental planes of the Cube of Common Sensory Logic. By this we mean that the planes are internal, but not centredissecting. If they were centre-dissecting, they would be Emotional Planes. Therefore, as Common Sense Agreements, they form the Mental Creativity of Common Sensory Logic. In context, this means that Common Sensory Logic is Detailed by the Creative Thought of Imagination. In essence, a Cube represents Practical Common Sensory Logic. Therefore, Practical Common Sensory Logic is Detailed by the Mental Creative Thought of Imagination.

If we add the points of intersection that the Tetrahedron Pyramids create, the six points created form an Octahedron of Nature or Attitudinal Behaviour. Therefore, Common Sensory Logic is Suggested by the Emotional Intelligence and Physical Creativity of Nature, and Detailed by the Mental Creativity of Common Sense. In this state, it becomes Nature-based Common Sensory Logic, which is the Common Sensory Memory of Attitudinal Behaviour. This forms a Common Mind.

Getting back to Nature Agreements, or Attitudinal Behavioural Agreements, when two or more Octahedrons of Nature form an Agreement, the Agreement is a product of the Emotional Intelligence and Physical Creativity of Nature. When the Octahedrons of Nature are in Agreement, the Physically Creative planes of Attitude become Mental planes of Thought. Therefore, the Nature Agreement is Mentally Detailed by the Creative Thought of Imagination. The Agreement is Suggested by Emotional Intelligence and Creatively Detailed by Imagination.

As previously stated, the Agreement point of the Nature Agreement is a Cuboctahedron point. Therefore, a Nature Agreement is based upon Self-awareness. Or, should I say, Self-awareness becomes the Agreement that is expressed by Nature.

If an Agreement is formed by two or more Cubes of Common Logic, the Agreement point is also a Cuboctahedron point of Self-awareness because when we divide the edges of a Cube in two it creates the twelve points of a Cuboctahedron of Self-awareness. The Square facets of the Cube become Mental planes of the Common Logic Agreement. Therefore, the Common Logic Agreement would become Mentally Detailed by Intellect.

In Consciousness, an Icosahedron represents an expression of Desire known as WILL. The Icosahedron has twenty Equilateral Triangle Physical or Practical facets, twenty Equilateral Triangle Mental facets, and twelve Pentagon Mental facets. The Pentagon facets are the bases of twelve Pentagon Pyramids of Desire outwardly directed. Therefore, it creates expressions of Desire. Initially, the Icosahedron of WILL is Physically Creative, Mentally Creative, and Mentally Motivated by the Pentagon planes of Motive, Personal Thought, or Consciousness. When two or more Icosahedrons of WILL form Agreements, the Agreement points become the points of an Icosidodecahedron of Intuition. The Physically Creative planes of WILL become Mentally Creative Planes within the Agreement. Therefore, Intuition becomes the Agreement of WILL, which becomes Mentally Creative and Mentally Motivated.


In essence, an Agreement is formed by intersecting Lines of Thought. A Line of Thought is the direction that Thought takes. If we look at Polygonal Agreements, which connect all the external points of a Polygon internally to create a centre-point, we can form Agreements of Creativity, Intellect, Motive, Love, which becomes Awareness, Belief, and many more. However, all odd sided Polygons do not form diagonals. They form Agreements of similarities. All even numbered Polygons create diagonals, which means they form Agreements of opposites. This is easy to understand when we relate them to Agreements formed by people. We can have people of similar Thinking coming together to form Agreements. We can also have people of opposing Thoughts coming together to form Agreements. With the latter, an Agreement would have to benefit each of the people in some way or form for that Agreement to be sustainable. Therefore, an Agreement of Attitudinal Behaviour could be an Agreement formed by entities with opposing Attitudes. Again, with the latter, each entity would have to benefit in some way or form from that Agreement.

Societal constructs rely upon Agreements for stability and Peace. Therefore, each member of a society would have to benefit from any Agreement formed. Making rules that do not benefit everyone in some way or form is a recipe for disaster. However, if everyone wishes to be at Peace, and following rules will create that Peace, then everyone is benefitting from an Agreement to follow those rules. Peace becomes the expression of that Agreement.


In Geometrical Thought Harmonics, Peace is a product of Mutual Respect, which is Synchronised Attitudinal Behaviour and Synchronised Respect. Harmony is Mutual Tolerance, a Synchronicity-polarised Emotional Intellect Agreement, which is a Harmony Nature Agreement. Therefore, Mutual Tolerance is expressed through Mutual Respect.

The picture below left shows 6 Harmony Nature Agreements in the Cuboctahedral axes. The picture below right shows the Logic states created by the intersections of the Octahedron edges of the 6 Harmony Nature Agreements. It becomes a multiple 6 of the 6 Logic states formed by the intersections of the Octahedron edges.














#### MIND

It fascinates me that a Nature Agreement, by its intersecting Lines, forms the Logic states related to each particular Nature Agreement with such order. Also, that the Square sides of each Logic state become the bases of Square-based Pyramids of Attitude in progression from Emotional Logic Agreements to Mental Logic Interpretations and then to Practical Logic Applications. All Logic states are expressed in succession by the Attitudinal Behaviour of the Nature Agreements. They are formed by the intersecting lines of Thought of the Nature Agreements and expressed as Logic-based Attitudes.

All Nature Agreements with polar planes that are Square, or multiples of the Square, create Charityawareness Nature Agreements when products of those Nature Agreements are formed in Cuboctahedral axes e.g. 6 Intellect-polarised Nature Agreements with Square polar planes, 6 Evolvability Nature Agreements with Icosagon polar planes, and 6 Harmony Nature Agreements with Dodecagon polar planes.

The Charity-awareness Nature Agreements are formed in the Octahedral axes by overlapping the Square facets of the Cuboctahedrons to form Octagon planes, which form Moral-polarised Self-awareness. Charity-awareness Nature Agreements are products of Moral-polarised Self-awareness.

#### **Focused Imagination: Visualisation**

Imagination is Creative Thought. Sense is focused Creative Thought, which is focused Imagination. Common Sense is a pure expression of focused Creative Thought or focused Imagination. Attitude is Intellect-based focused Creative Thought or focused Imagination, which is Receptive and Constructive Creativity. Desire is Motive-based focused Creative Thought or focused Imagination, which is Personal or Conscious Creativity.....a Wish. Awareness is Love-based focused Creative Thought or focused Imagination, which is a Reflex Responsive, programmed, and Impulsive Agreement of Creativity or Imagination.

Nature is a Physically Creative expression of Emotional Intelligence, which is a Physically Creative expression of what has been Suggestively taken on board and built upon by Intellect. WILL is a Physically Creative and Mentally Creative expression of Motive, Personal Thought, or Consciousness. Intuition is a Physically Creative expression of Emotional Intelligence and an Emotionally Creative Impression of Practical and Interpretative Consciousness. Instinct is a Personalised expression of Mentally Creative Agreements that form Mental Intelligence. Self-awareness is an Emotionally Creative Impression of Practical Intelligence and Practical Imagination.

Visualisation is a product of Imagination or Creative Thought. Focused Visualisation is Sensory, which labels, recognises, and recalls Memory. It categorises Thoughts into Memory and is essentially explicit and direct. Therefore, Common Sense is unbiased Visualisation. Attitude is Receptive and Constructive Visualisation. Desire is Motive-based, Personal, or Conscious Visualisation. Awareness is a Reflex Responsive, programmed, and Impulsive Visualisation Agreement. In context, Nature, which is an Attitudinal expression of Emotional Intelligence, would become a Suggestively Receptive and Constructive expression of Physical Visualisation. WILL, which is an expression of Desire, would become a Motive-regulated, Personal, or Conscious expression of Mental and Physical Visualisation. Instinct, which is Personalised Common Sensory Logic, would become a Motive-regulated, Personal, or Conscious expression of Mentally Agreed Visualisations. Intuition produces Personalised Attitudinal Behaviour that is determined by Impressions of Desired Awareness. Therefore, it Suggestively expresses Receptive and Constructive Visualisations that are Suggested by Reflex Responsive, programmed, and Impulsive Visualisation Agreements created by Impressions of Physically Motivated, Personal, or Conscious Visualisation Agreements created by Impressions of Physically Motivated, Personal, or Conscious Visualisations.


## **Interactive Visualisation of Conscious Thought**

It has been previously stated that Life as we know it is an Interactive Visualisation of Conscious Thought. It was also defined as a Virtualised Environmental Construct of Mind. Therefore, in Geometric form, what would represent an Interactive Visualisation of Conscious Thought?

Interaction allows an entity to influence and be influenced by an environment. It produces experience. As previously stated, Visualisation is a product of the Creative Thought of Imagination. Conscious Thought is Motive or Personal Thought. An Interactive Visualisation could be represented as two overlapping Equilateral Triangles of Imagination, which would be experiential Imagination. An Interactive Visualisation of Conscious Thought could be proposed as a Motive-regulated experiential Imagination. However, a Visualisation of Conscious Thought could be represented as a Motive-based Sense of Desire, which is a Wish. If this were the case, an Interactive Visualisation of Conscious Thought could be represented as two overlapping Pentagon Pyramids of Desire, which would become Belief-interactive Desire.....Choice-based Desire.

The picture below left shows 4 Pentagon Pyramids of Desire formed within a Decagon prism of Beliefpolarised Practical Logic Application. They create polar centre-point Decagons of Belief, which become Agreements of Belief. Therefore, two overlapping Pentagon Pyramids of Desire connected to those centre-points or Agreements would form Belief-polarised Agreements that are expressions of Desire. In relation to Visualisation, this would form Belief-polarised or Consciously experienced Visualisations, which are Choice-based experiential Visualisations.

The picture below right shows a Decagon Prism of Belief-polarised Practical Logic Application encapsulating the Pyramids of Desire. A centre-point Decagonal Prism represents an Agreement of opposing Beliefs or Choices. In this case, it represents an Agreement of opposing experiential Desires, which would be an Agreement of Consciously experienced Visualisations.



In essence, Actuality, or Actual Reality, is a product of Belief-polarised Practical Logic Applications, which is the final Logic state of a Belief Mind formed by Affirmative Nature Agreements. Therefore, an Interactive Visualisation of Conscious Thought could refer to an Actual Reality or Actuality.

#### Virtualised Environmental Construct

In Geometrical Thought Harmonics, what would represent a Virtualised Environmental construct? Virtuality, or Virtual Reality, is a product of the Virtual Brain, which is represented by a Dodecahedron of Instinct. It is also a product of Awareness Logic, which is a Love-based Creative Logic Agreement. Instinct is a Personalised product of Common Sense Agreements or Common Logic. Awareness Logic is a Logic state of the Awareness Mind, which is a product of Tolerant Nature Agreements. An Environment is circumstantial surroundings or conditions. Social or Environmental Conscience is a Personalised product of experiential Creative Logic, which is a Logic state of the Awareness Mind. In mainstream knowledge, Virtual means something that can be experienced by the Senses but is not

Actual. Therefore, it is not Believed to be real.

"Virtuality became Actuality and imprisoned the Mind". Virtual Reality became Actual Reality and imprisoned the Mind. What does this mean? Virtuality is not Believed to be real and is a product of the Virtual Brain and Awareness Logic, which is a Love-based Creative Logic Agreement, and Actuality is Believed to be real and is a product of Belief Logic or Belief-polarised Agreements of experiential Desire. They are both Agreements. One is a Belief-polarised Agreement of Desire and the other is an Agreement of Awareness and Common Sense. They are also Sensory Visualisations. One is a Sensory Visualisation of experiential Desire and the other is a Sensory Visualisation of Awareness, as well as a Sensory Visualisation of Common Sense. This gives us a clue.

An Interactive Visualisation of Conscious Thought is a Consciously experienced or Believed Visualisation that is a product of Desire. A Virtualised Environmental Construct would be more like a Dream, which is not Believed to be real. Therefore, in relation to the statement "Virtuality became Actuality and imprisoned the Mind", the Dream became Believed. In context, when the Dream became Believed we became grounded or embedded into the Dream as Actualised Avatars.

#### **Self-perpetuating Interaction**

How could a Dream become Believed to be real? Belief is a declaration of Personal Preference or Choice. It is Preferentiality. In essence, it is a product of experience-based Consciousness. Experience is Interaction, which allows an entity to influence and be influenced by an Environment. It allows an entity to influence and be influenced by circumstantial surroundings or conditions. In this case, the Environment, or the circumstantial surroundings or conditions, is a Dream. Therefore, by Interacting with the Dream it allows an entity to influence the Dream and be influenced by the Dream. If the Dream was recognised to be a Virtualised Environmental Construct, and not an Actual Reality, it would be more likely for an entity to influence the Dream. If it were Believed to be real, it would be more likely for an entity to be influenced by the Dream. If that were the case, a Dream could become Self-perpetuating. By this, we mean that the Dreamer, or in the case of a shared Dream the Dreamers, would not take any responsibility for the circumstantial surroundings or conditions. Therefore, the circumstantial surroundings or conditions would seem to be Self-perpetuating. In other words, the Dream would seem to unfold without any input from the Dreamer or Dreamers. However, in reality, for want of a better word, the Dream would be a product of the Dreamer's or Dreamers' Thoughts, which would be responses to or opinions of the environmental illusion. Therefore, the responses to or opinions of the illusionary circumstantial surroundings or conditions would either reinforce or deteriorate the illusion of circumstance.

#### Exposé of a Dream

If we examine the Nature of a sleep-related Dream, we may see many people within a Dream. Quite often, we don't recognise their faces. However, in many cases, we seem to know them. They seem to be associated with us in some way or another. Also, the environment can seem familiar. In the same tone, the Avatar that we use to navigate the Dream may not be the one we recognise as us in the so called awake state. I have experienced this many times. Sometimes, I will look for a mirror within the Dream so I can see who is looking back. The person in the mirror usually has a different face, and a different body. In context to the Mind or Dream that we exist within, what if Consciousness, which is simply a product of Personal Thought, was Dreaming in the same manner. The people in the Dream could symbolise or represent the many facets of its own Potential. This raises many questions. What if this Dream has become an Interactive Visualisation of an infinite number of possible Personalities of the One Consciousness, the Consciousness that is us, or maybe just "I" creating many possible selves from the One SELF?

"I" am a Thinking entity that Visualises Thoughts into Dreams. The more questions that "I" ask, the more complex the Dream becomes as "I" manifest infinite reflections to those questions.

What if "I" represents Introspection, which is examining One's own Thoughts and Feelings? Why do our Avatars have two eyes? Does it symbolise two "I"s. One would be the Source, and the other would symbolise a separation from the Source. Two separated "I"s. Duality?

Common Sense is a pure expression of focused Imagination. It is an unbiased Visualisation. Attitude is an Intellect-based expression of focused Imagination, which is a Receptive and Constructive Visualisation. It Visualises what it has taken on board and built upon. Nature is an Attitudinal expression of Feeling, which is an expression of Emotional or Suggestive Intelligence. It is the position a Body takes in relation to how it Feels about the Self, about the environment, and about the experiences it has within the environment. Therefore, it is the position a Body takes in relation to what has been Suggestively taken on board and built upon, a Visualisation of Feelings......Visualised Behaviour.

"I am that I am" versus "I am that I choose to be". One is the essential or fundamental "I", which is Pure Potential, and the other is a product of experiential Consciousness, which is the "I" of Preferentiality, Belief, or Choice. However, the Dream that is Mind has become a product of many Visualised "I"s of Preferentiality, Belief, or Choice. They are Visualisations of Pure Potential.

A Personality, or Personal Reality, is an Identity-based Visualisation, which is a Visualisation of experience-based Conscious Intelligence. As Pure Potential is an infinite source of possible Thoughts, the Dream that is Mind is a Visualisation of those possible Thoughts.

Intellect takes on board and builds upon concepts. It accumulates Thoughts. Logic is a Library Of Growing Intelligent Concepts, which is Memory. Mind is a Logical construct initiated or Suggested by Feeling, which becomes Behavioural Memory. Therefore, the Dream that is Mind is a Visualisation of Behavioural Memory.....an evolving Museum of the infinite possible Attitudinal Behaviours of Pure Potential. Attitudinal Behaviour, which is Nature, is a Physically Creative expression of what has been Suggestively taken on board and built upon......Visualised Feelings.

#### ENERGY

Expressive Natural Entity Radiated Gamut Yield – E.N.E.R.G.Y.

Torrid Heart Of Unity Guided Harmonic Transmission – T.H.O.U.G.H.T.

Thought is Energy. It is a response to or an opinion of an Environment. In essence, it is the Potential to Think, which produces Thoughts.....designs of Thought. Therefore, a design of Thought is purposed Energy, which has an Intention or Agenda. Pure Potential is available Energy, unpurposed or undifferentiated Energy.

The Equilateral Triangle has an Intention or Agenda of Imagination or Creative Thought. The Square has

an Intention or Agenda of Intellect or Receptive and Constructive Thought. It takes on board and builds upon concepts. The Pentagon has an Intention or Agenda of Motive or Personal Thought, which is Consciousness. A Hexagon has an Intention or Agenda of Love or Unconditional Acceptance, which is Reflex Responsive, Programmed, or Impulsive Thought. A Heptagon has an Intention or Agenda of Perception, Understanding, or Sight. An Octagon, which is two overlapping Squares of Intellect, has an Intention or Agenda of Morality or Experiential Judgement, which is Experience-based Receptive and Constructive Thought. It takes on board and builds upon Experiences. A Nonagon, which is three overlapping Equilateral Triangles of Imagination or Creative Thought, has an Intention or Agenda of Forgiveness or Creative Mediation. A Decagon, which is two overlapping Pentagons of Motive, Personal Thought, or Consciousness, has an Intention of Belief or Choice, which is Experience-based Motive, Personal Thought, or Consciousness. A Hendecagon has an Intention or Agenda of Reflection. A Dodecagon, which is three overlapping Squares of Intellect, four overlapping Equilateral Triangles of Imagination, and two overlapping Hexagons of Love, has an Intention or Agenda of Synchronicity, which is a Coordinative Impulse. It is Creative, Receptive, Constructive, and Impulsive.

In light of that information, Imagination produces Visualisation, Intellect produces Behavioural Memory, Motive produces Consciousness, Love, or unconditional acceptance produces Reflexes, Programs, and Impulses, Perception produces Hindsight, Insight, and Foresight, Morality produces codes of Conduct, Forgiveness produces Mediation, Belief produces Preferentiality or Choice, Reflection produces Consideration, and Synchronicity produces Coordination.

What would initiate purpose or differentiation? In relation to the Potential to Think, Thinking would initiate purpose or differentiation e.g. Creative Thinking would initiate Visualisation. Therefore, a Thinking Entity would simply be responding to its circumstance or condition. In essence, it would be forming Opinions of that Essence.

What happens when an Essence forms an Opinion of its Essence? I guess it would depend upon the Opinion. If all Thought is accumulated into Memory, there must be a way to remember what that Opinion could have been. It could give some Insight into why everything is the way it is, and why we are the way we are.

I wonder what our first Thoughts were when we developed the ability to Think within the womb, which was our first environment as an Avatar of the Mind? Those Thoughts would have been Opinions of circumstance or condition. Did we cry upon birth because of the shock of leaving a familiar environment? In context, as the initial Essence, which is Pure Potential, what would our response have been when we first Visualised our Thoughts, when we began to Dream? Could that moment have symbolised a "Big Bang" within the darkness of Space? In symbolic or Dream form, Space could symbolise Pure Potential, the Essence from which all manifests....an infinite Source of possible Thoughts. It could have been the beginning of Mind, which is an accumulation and categorisation of Thoughts.

#### **MEMORY**

Matter Experienced Mind Of Registered Yield - M.E.M.O.R.Y.

Mediative Instructional Nature Delegation - M.I.N.D.

Memory Accumulative Thought Transmuted Energy Realisation - M.A.T.T.E.R.

Memory is an accumulation of Thoughts. Intellect, which is Receptive and Constructive Thought, takes on board and builds upon concepts. It accumulates Thoughts. Therefore, Memory is a product of Intellect. Logic is a Library Of Growing Intelligent Concepts. It is also a product of Intellect. However, a Library categorises Thoughts. Therefore, Logic is an accumulation and categorisation of Thoughts. Mind is a product of Nature. It is a Logical construct initiated or Suggested by Feeling. Sense, labels recognises and recalls Memory. It categorises Memory through labelling. As Nature is an Attitudinal expression of Feeling, and Attitude is an Intellect-based Sense, then Attitude categorises or labels Feelings to form Behavioural Memory. Therefore, Mind is Memory of Behaviour.

If we examine the structure of a Nature Agreement, it creates Logic states from the intersections of the Octahedron edges. Those edges are Lines of Thought. Therefore, Logic states are created from the intersecting Lines of Thought of a Nature Agreement. As Nature is Attitudinal Behaviour, it is easy to understand why we would label a Mindstate as a product of Behavioural Logic, which is Behavioural Memory.

If we take another look at the structure of a Nature Agreement, the Logic states are produced by that Nature Agreement and then expressed through the associated Feeling states that manifest from that structure e.g. an Intellect-polarised Nature Agreement is a product of two Octahedrons of Nature that create Common Sensory Logic from the intersecting Lines of Thought. It is an Agreement of Nature and also an expression of Nature as Attitudinal Feeling. An Awareness-polarised Nature Agreement is a product of three Octahedrons of Nature that create Love Logic and Experiential Creative Logic from the intersecting Lines of Thought. It is expressed by Awareness-based Feeling, which is Respect. Therefore, the Feeling state that expresses a particular Nature Agreement is dependent upon the Trait of Polarisation e.g. a Belief-polarised Nature Agreement would be expressed by Belief-based Feeling, which is Trust. A Synchronicity-polarised Nature Agreement would be expressed by Synchronicity-based Feeling, which is Mutual Respect. Therefore, Nature would express Attitudinal Behavioural Memory. Respect would express Awareness-based Behavioural Memory. Trust would express Belief-based Behavioural Memory. Mutual Respect would express Synchronicity-based Attitudinal Behavioural Memory. Virtue would express Moral-based Attitudinal Behavioural Memory. Personality would express Identity-based Attitudinal Behavioural Memory. Retrospection would express Hindsight-based Behavioural Memory. Premonition would express Foresight-based Attitudinal Behavioural Memory.

Nature, Virtue, Mutual Respect, Personality, and Premonition are Attitudinally expressed Behaviours. Respect, Trust, and Retrospection are Behavioural states but not Attitudinally expressed until they become experiential. Virtue is an experiential form of the Attitudinal Behaviour of Nature. Mutual Respect is an experiential form of the Awareness-based Behaviour of Respect. Personality is an experiential form of the Belief-based Behaviour of Trust. Premonition is an experiential form of the Hindsight-based Behaviour of Retrospection.

## **Evolution of Mind/Dream**

As previously stated, every question initiates reflections of those questions into the Dream, which is Mind. Therefore, the Dream could begin with simple reflections of Thought and then become more and more complex as we question the Nature of the Dream e.g. we might begin with a simple Avatar and then our need to understand what we are, how we came about, and what our purpose is could manifest an infinite number of reflections to those questions. Therefore, the structure of the Avatar, and the environmental variables, could become more complex e.g. we may delve into the structure of the Dream Body, which is the Avatar, and questioning could manifest a complexity within the Avatar. This could manifest internal structure like blood, bone, organs, DNA, hormones, muscle, etc. We could begin with an Avatar that had no internal parts, just a Visualisation of form, and end up with an extremely complex system of internal parts dependent upon the depth of questioning. By wishing to know more about how we exist we could develop technology that allowed us to Visualise Atoms and molecules as more complex parts of what we have determined to be Life. The more we seek, the more we Visualise answers to what we are seeking. Then, we could seek more knowledge by analysing the Atomic structure, which could manifest more complexity into the Dream. Thought manifests! Every question is going to manifest an answer, or many possible answers, into the Dream. We could imagine Methodologies to explain creation. Then we could become governed by those imagined methodologies. The more complex the Methodologies, the more difficult it would become to create anything within the Dream. In other words,

Time would become a factor in the Visualisation process. We would need to create complex technology as a means to reduce the Time factor. Life could become so complicated that only initiates of the Technology would be able to create anything worthy, or maintain the Technology so as to keep creating anything worthy. Think about it!

"We are what we Think". "As we Think, we shall become". "Thought is the beginning of all Creation". "Be careful what you Wish for, because you just might get it". Desire is a Wish. It is a Motive-based Visualisation, which is a Conscious Visualisation.

Could we have imagined Gods to have created this reality, and us, due to the questions that we asked? What are we? Where are we? How did we come about? What is our purpose? Who created us? Thought manifests! Mind could manifest infinite possible answers to those questions.

Questions are Wishes. Prayers are Wishes. Desire is Motive-based focused Creative Thought, or Motive-based focused Imagination. "Imagination is the Womb of Creation".

How could disease have manifested into the Dream? What is disease? It is what it sounds like, dis-ease. If we are not at ease with our environment, Thought could manifest something into the Dream that would symbolise or Reflect those Thoughts. If we manifested a dis-ease, we could then seek a cure. Thought manifests!

In a simple environment, and with a simple understanding of how Life works, we could manifest plants as remedies to our ailments. A simple Wish for a cure could guide us in finding a cure, or manifesting a cure into the Dream.

Within the Mind or Dream, Intuition and Instinct have become forms of Guidance. Intuition is impressed by Desired Awareness, and Suggests Choices and Personalised Attitudinal Behaviour as reflections of that Desired Awareness.

Instinct is Guidance of Logic, Personalised Common Logic to be more precise. Common Logic is a product of Common Sense Agreements, Agreements of Common Sense, which is unbiased focused Creative Thought. Logic is Memory of Behaviour. Therefore, Intuition is Personalised Guidance of Feeling and Instinct is Personalised Guidance of Memory.

How did Guidance manifest into the Dream? The same way everything else manifested. It would have been a response to a Wish for help. It seems likely that in navigating the Dream of Life we would find ourselves in need of help. Thought manifests! This raises some interesting questions. How would we respond to that Guidance, especially if it manifested as a voice within our own Thoughts? Could that Guidance have been mistaken for the voice of a GOD, which is simply Guidance Of Divinity? DIVINITY as an acronym means Direct Intuition Via Initial Nature In Total Yield. Intuition produces Personalised Nature, which is Personalised Attitudinal Behaviour. In essence, it connects all Living Things, Nature In Total Yield. Therefore, Nature would respond to our need for help. It could come from another entity that was impressed to help. It could come from the Memory of previous experience. Although, it could also come from the Memory of another entity, or from the entirety of Memory as an accumulation of Thoughts that have become Mind, the same Thoughts that created the Dream. Mind is a shared Space. All Personalities of Mind have access to Memory that they have all contributed through experience. What we access can be accorded to our way of Thinking, through a simple function of attraction. This can be both beneficial and detrimental, dependent upon our Thoughts. If depressed, we could access Memories that reflected depression. If Happy, we could access Memories that reflected happiness. To be more precise, Thought is Energy. Therefore, we could access Energy that promoted depression or Happiness. It could manifest as Feelings, which are expressions of Emotional Intelligence. Emotion is Suggestive. Intellect takes on board and builds upon concepts.....Thoughts. Therefore, Feeling expresses what has been Suggestively taken on board and built upon.....what has been Suggestively accumulated into Memory. In other words, we could access Feelings from a so called

Universal Memory. They would not have to be an accumulation of our Personal Feelings, just Feelings from a shared Mind that reflected our particular mood. The Mind boggles!

#### A Shared Mind

Mind is a Logical construct initiated or Suggested by Feeling, which is an expression of Emotional Intelligence. Nature is an Attitudinal expression of Emotional Intelligence. However, the fundamental principle of Nature is Feeling. It is an expression of what has been Suggestively taken on board and built upon, what accumulates into Memory as Behavioural Logic states or Behavioural Libraries. How is it possible to share a Mind? If we examine Psychological principles that deal with Multiple Personality disorders, many Personalities are capable of sharing the same Mind. However, in that methodology, we are talking about a Person with multiple Personalities. In essence, there is no difference. We are Personalities of the One Mind as Identified Attitudinal Behaviours of that Mind, which have manifested an Interactive Visualisation of Conscious Thought, a Virtualised Environmental Construct. Is sharing One Mind a problem? If we examine more closely our Personal Reality, which could have many different environmental circumstances, we adapt to those circumstances by changing our Behaviour to suit the moment. If we need to take care of a family, our Behaviour must change to consider the needs of the family. If we need to be security conscious, we would take measures to reinforce that security. One way to reinforce that security could be learning Self-defence. Therefore, we must adopt a more aggressive Nature....a more aggressive Attitudinal Behaviour. If we need to afford to Live in a Capitalist society, we must become more financially savvy. Therefore, our Behaviour must change again. We are still the same Person, but utilising our many possible talents, or, utilising our many possible Personalities. Why would a Mind of Pure Potential be any different? The many Personalities of that Mind would simply enact Behaviours according to circumstances and conditions.....according to environmental variables. However, multiple Personalities in the same Person can create conflict and confusion. Therefore, a Mind of Pure Potential could suffer the same outcomes if those Personalities became competitive and threatened. Why would a Personality of the same Mind become competitive or threatened? If a Personality felt more important than other Personalities, and became very dominant, other Personalities could Feel threatened by that dominance. How we Feel about an environment determines how we Behave within that environment. Therefore, a competition to prove worthiness or privilege could ensue.

There is an interesting twist to consider. Every Lifeform in this so called reality, which is a Dream of Pure Potential, could be symbolising the One Mind interacting with its many Personalities. However, if there has been a disconnect those Personalities would have no idea that they were Identities of the One Mind, sharing One Dream.

What would cause a disconnect? How could One Mind develop an infinite number of disconnected Identities?

An Identity is a product of experience-based Conscious Intelligence. In essence, to be Conscious is to have Personal Thought. Personal, usually means private.....private Thoughts. Therefore, an Identity is a product of experiential Personal Intelligence. It is also a product of Belief or Preferentiality. Intellect takes on board and builds upon concepts. It is Receptive and Constructive. Belief is a declaration of Personal Preference or Choice. Therefore, an Identity takes on board and builds upon Personal/Private experiences and Personal/Private Preferences. By doing so, it forms an Identified Attitudinal Behaviour or Personality. In context, the development of Personalities could cause the disconnect in question. Therefore, a disconnect could be a Natural occurrence of an evolving Conscious experience. If that is the case, Consciousness could be a subsequent separation of developed Preferences, a partitioned Mind of Private Thoughts.

The Dream of Life certainly resembles a Partitioned Mind of Private Thoughts. It is like a jigsaw puzzle where all of the parts are trying to create their own picture.

## Wakeup Call

The Dream of Life manifests reflections to our Questions, Desires, Prayers, or Wishes. The more complex the Questions, Desires, Prayers, or Wishes, the more complex the Dream becomes.

Reality as we know it is just a Dream. In essence, it is just Visualised Energy. Therefore, there is no waking up from the Dream. However, there is waking up to the Dream and within the Dream. In context to a sleep-related Dream, have you ever realised that you were Dreaming and then went about changing what you didn't like? I have, many times. I learnt that skill when I was just a child. Therefore, our goal should be to respect our other Personalities, and be more responsible for what we Visualise into the shared Dream, the one where we have Believed ourselves to be awake.

I realise how fantastic this may sound to most people, and that should be the Motivation to make the change. Our Potential is fantastic! We are creating a Movie. However, we must understand that there are an infinite number of writers, Directors, producers, actors, and critics. Therefore, Synchronicity is vital. To create a better Movie, we must coordinate and cooperate.

How do we go about reconnecting? The interesting thing to note is that we are always connected Unconsciously. A Conscious disconnect manifested from the Desire for privacy. Consciousness, as we have stated, is a product of Personal Thoughts, which is Private Thoughts. Living within a shared Mind, or a shared Dream, requires Mutual Respect and Mutual Tolerance to create Peace and Harmony within the Mind or Dream.

Competition and Opportunism does not create Peace and Harmony. It simply reinforces a disconnect. Worship does not create Peace and Harmony. It is disrespectful to the SELF, or selves. However, we should understand why those Behaviours manifested once we have recognised the cause. An unfortunate separation due to a Wish for Privacy within a shared Mind was the cause.

It may sound scary to Think about reconnection if we are afraid that our Thoughts will become known to All. There is a simple solution to that problem. Have better Thoughts! Although, that may sound easier than it is. We have become so used to hiding our Thoughts from others because we fear criticism. However, some people do not have that problem. They speak their Mind, and then deal with the outcome. It isn't wrong to have differing Opinions. It simply gives a reason for open discussion. Agreements are formed through open discussion. They are not formed by hiding or disguising our Opinions. Pretending to Agree creates more problems when the Truth is known. It is much better to disagree than to falsify an Agreement.

As previously stated, how we Feel determines how we Behave within an environment. Therefore, Feeling more comfortable with the SELF is a good start to create a better environment. It isn't about Feeling good within a bad environment. That doesn't make sense. If we want a better environment, the present environment must be recognised as unacceptable. Thought manifests! However, a common Theme is essential for creating Peace and Harmony. In essence, the Common Theme should be Peace and Harmony, which are both products of Synchronicity or Coordination.

## **Natural History**

History is a record of events. Nature is Attitudinal Behaviour, which is the position a Body takes in relation to what has been Suggestively taken on board and built upon. It is a Physically Creative expression of Feeling. However, History is also Chronological.

Natural History is a Chronological record of Attitudinal Behaviour. In essence, it is Chronological Memory of Attitudinal Behaviour. Nature Agreements create that Memory and Attitudinally express that Memory. Therefore, they can Visualise or recall that Memory.

Is it possible to alter History, to create a better past? Why would we want to alter History? We are products of experience. Therefore, we can be plagued by unwanted Visualisations of those experiences. What do we mean by that? Have you ever created the same circumstances or conditions that have occurred previously? We seem to replay events according to a revolving Mindset. Oh no, it happened again! Sounds familiar, doesn't it.

Life seems to replay the past if it has not been dealt with properly. Why would it do that? What do we mean by 'dealt with properly'? Sometimes, we may Wish that we had done something differently, that we had dealt with a situation in a better way. Be careful what you Wish for. The merry-go-round can be difficult to get off.

Life as we know it has become a revolving door. Fashions go around and come around. Behaviours are replayed over and over again. Movies are remade over and over again. Life is a Movie. The plot remains, but the scenery and actors change. While-ever a Theme remains, Lifeforms will continue to reflect that Theme. I wonder what the Theme of this reality is.

What seems to be a constant in this reality? Accumulation of wealth and possessions could be a constant. However, that may only be a Human endeavour. Competition is definitely a constant that plays out in this reality. Hierarchical privilege and dominance is definitely a constant that plays out in this reality. A quest for land and resources is probably another constant. Survival of the fittest could be another constant. However, that probably relates to Hierarchical privilege and dominance. Can we see a Theme?

How we Feel determines how we will Behave within an environment. It is an expression of what has been Suggestively taken on board and built upon. Feeling Suggests Behaviour. Is there a common Feeling that keeps creating similar circumstances and conditions?

Do we Feel safe within this Dream? Do we Feel supported within this Dream? Do we Feel equally accepted within this Dream? Can we see a Theme?

We are Personalities of the One Mind, sharing the same Dream. If Personalities of the One Mind were competitive and opportunistic, and those Personalities were contributing to the Interactive Visualisation of Conscious Thought that we call Life, what would manifest into the Dream of Life? If that Behaviour continued, would the Dream of Life continually reflect that Behaviour? That would be a yes! I Think we have found a Theme.

Competition and Opportunism are consequences or symptoms of disconnection. Unity and Equality would solve that problem. If we Wish to create a better Dream, we must have better Thoughts. Nature Agreements are Agreements of Attitudinal Behaviour. In general, we seem to have Agreed that Competition is a good thing. Therefore, our Behaviour reflects that Agreement. We have also Agreed that declaring ownership of resources is a good thing. Our Behaviour reflects that Agreement. Again, in general, we seem to Agree that Hierarchical privilege and dominance is a good thing. Our Behaviour reflects that Agreement.

Nature Agreements create Logic states that form Mindstates, which are Behavioural Memories. If we don't change the Agreements of Attitudinal Behaviour that we have manufactured and continually express, Life will continue creating the merry-go-round effect. What goes around, comes around!

## Interpretation

In Geometrical Thought Harmonics, Interpretation is represented by connecting the points of a Polygon internally to form a continuous line connection e.g. if we connect the points of a Pentagon internally to create a continuous line connection it forms a Pentagram, which becomes an Interpretation of Motive, Personal Thought, or Consciousness. In this instance, GRAM means something written or recorded as an Interpretation of Thoughts e.g. Polygram or telegram etc. In essence, a message is an Interpretation of Thoughts.

### **Chronological Memory**

Chronological means Time-related Logic, which is an accumulation and categorisation of Time-related events. Within the Mind, what represents Time-related Logic?

TIME as an acronym means Thought-Intention-Motivation-Expression. Motive is Personal Thought or Conscious Thought. An expression of Motive could be Desire, which is a Motive-based Sense. It can also mean a Conscious Visualisation because Sense is focused Creative Thought or Imagination. A Visualisation is focused Imagination. However, Desire can also be focused inwards to create Impressions of Desire. Therefore, as previously stated, WILL is an expression of Desire? However, we could simply define a Motivation Expression as an expression of Consciousness. If we use that definition, Chronological Memory could be Conscious Memory. Therefore, Time is a product of Consciousness, which is Personal Thought. It is Motivation-related. This makes sense because we usually allot a timeframe to things that are happening or in Motion. In essence, TIME is a Personal indulgence. If this is correct, an Unconscious state would not be subject to TIME. If there is an Unconscious Mind, it would not be subject to TIME. Unconscious or Impersonal Memory would have no Chronological reference. What would we regard as Impersonal Memory?

#### **Impersonal Memory**

Impersonal should be easy to define. It is not Personal. However, is it that simple? Not being Personal could mean not Private. When someone says it isn't Personal, it usually means it isn't directed at you or meant to upset you. It could also be stated as having nothing to do with you. Therefore, could Impersonal Memory be an accumulation of Thoughts that have nothing to do with us, that are not our Personal Thoughts.

Could an Unconscious Mind be an accumulation and categorisation of all Thoughts, without Private designation or Chronological reference. If this were the case, how could that Memory make sense? Categorisation is to label and organise into relationship. Therefore, it could make sense but not have any periodic reference. You wouldn't know whether an event happened before or after another event. There would be no 'when' or 'who' associated with Memory.

If we accessed that Memory, we might Think it to be our experiences. This could explain why some people Think they are reincarnations of previous Entities, not just people. They could be Visualising or reliving Memories in general rather than Chronological and Personal. The only reference would be environmental or cultural distinctions. The scenery might be recognisable, and cultural Behaviours might be recognisable. This raises other questions. We exist within a shared Dream, within a shared Mind. Therefore, are our Thoughts only ours? Are we Visualising Thoughts that are not as Private as we Thought? They could be from many entities within the shared Dream. Accepting them to be ours, means Believing them to be ours.

Connection is an interesting phenomenon. When we make close connections with others, we can finish their sentences for them and know how they are Feeling at any given Time. In essence, the line between them and us becomes blurred. The closer the connection, the more blurred that line becomes. We become One!

In my experience, there have been times when I have documented information that manifested within my Thoughts. When I shared that information with others, some people asked if I had read a particular book. I declared that I hadn't. The reason they asked was because the same information was in that book. I have experienced that many times. I have come to realise that all information is available to those who resonate with the information. I concluded that it must be the Unconscious or Impersonal Mind, the shared Mind or Dream. Are we simply having a Personal experience within the so called Universal Mind or Dream, the Mind or Dream of Pure Potential, a Mind or Dream of infinite possibilities?

### **Proxy and Placebo**

A Proxy is an authority to do something or represent something that would normally be done by another thing or person. It could have wide-ranging applications. However, within the Mind or Dream, what could that reflect?

Without mentioning the mainstream concept, a Proxy could be a symbol that represents or allows control. If a Thinking Entity was unaware that its Thoughts were being Visualised into its environment, and a substitute was envisaged to be the initiate, that substitute would be a Proxy. Therefore, an imagined Supernatural entity could become the Proxy for granting Wishes or answering Prayers. A Supernatural entity could be given authority to grant those Wishes by simply Believing it to have that authority. It would be a Subconscious appointment. Why would we use the term 'Subconscious'? Unconscious means to have no Personal or Conscious input. Subconscious means Personally programmed, which can simply occur through repetitive Conscious Thoughts, responses or Opinions. Programs are created through Unconditional acceptance, which we have labelled as Love. Therefore, if we Unconditionally accept that a Supernatural entity exists, and that it has the authority to grant Wishes and answer Prayers, those Wishes and Prayers could manifest. In essence, Love would manifest reflections of those Wishes and Prayers. Unconditional Acceptance would manifest reflections of those Wishes and Prayers. We are a Thinking entity that Visualises its Thoughts into Dreams! Witchcraft uses Proxies in its indoctrination. One example would be a Pentagram, which represents an Interpretation of Motive, Personal Thought, or Consciousness. Through an Unconditional acceptance of that symbol to have the power to manifest Thoughts, Thoughts could be Visualised into the Dream of Life. In all cases, Love is the initiator. Without the Unconditional acceptance of Love, we tend to rely upon Belief, which is simply a product of experiential or experience-based Consciousness, a declaration of Personal Preference or Choice. However, Emotional Belief is Suggestive. Therefore, the power of Suggestion comes into play, which is a Placebo effect.

Faith Healing is another example of the power of Proxy if it is Faith in an imagined Supernatural entity. Faith is a Trust-based expression of Desire, which is Trust-based WILL. Trust is Emotional Belief-based Feeling or Behaviour, which is Suggestive. Feeling is an expression of Emotional Intelligence, which is Suggestive. However, it depends upon the object of Faith. It could be Faith in the SELF to Heal or it could be Faith in a Supernatural entity to bring about the Healing. In essence, Faith has nothing to do with Love. It is Belief-based. However, if we had Faith in a Supernatural entity's ability to Heal, or our ability to Heal, and we Unconditionally accepted that Belief, Healing could manifest. In context, an Unconditional acceptance of a Suggestive Belief, Suggestive Awareness, Suggestive Morality, Suggestive Synchronicity, or any other Polygonal Trait.

Suggestive Intelligence would Suggest what concepts to take on board and build upon. Suggestive Belief would Suggest Personal Preferences or Choices. Suggestive Awareness would Suggest Sensory Reflex Responses or Impulses. Suggestive Morality would Suggest codes of conduct. Suggestive Synchronicity would Suggest Coordination. A Placebo effect is the power of Suggestion.

### **Unconditional Acceptance**

Sometimes, we define Love as Unconditional Acceptance. However, very few people understand the term. We use the term, Love, very loosely. When we say that we Love someone or something, it very rarely means that we Unconditionally Accept someone or something. Therefore, the term Love is simply something that we think we should say in a particular situation or circumstance. If we investigate the term more closely, Unconditional Acceptance produces programs, reflex responses, and impulses. If we said that Love was Impulsive, very few people would disagree. However, if we said that Love produces programs and reflex responses, very few people would understand. Changing the term to Unconditional

Acceptance allows for a better understanding of how programs and reflex responses are produced. In essence, Life is a product of Unconditional Acceptance. It is a product of programs and reflex responses.

DNA is a product of Unconscious and Subconscious programs, which produce Unconscious and Subconscious reflex responses or Impulses. Hormones are products of Unconscious and Subconscious programs, which produce Unconscious and Subconscious reflex responses or Impulses. Hexagonal Atomic structure is programmed.

A Beehive is Hexagonally constructed. Is it a product of programming? In context, a Beehive is a nursery. Therefore, if we said that a Beehive was produced out of Love, it would make sense because it is a nursery. If we said that a Beehive was a product of Programming, it would also make sense. It has been noticed that within Stellar nurseries there are Fullerenes or Bucky Balls. A Fullerene is a Geometric sphere made up of external Pentagon and Hexagon facets. A Pentagon represents Motive, Personal Thought, or Consciousness. As we have already stated, a Hexagon represents Love or Unconditional Acceptance. When a Pentagon is connected to a Hexagon by two points or a side, it represents Subconscious programming. Another definition would be Motive-regulated Physical Love or Love-regulated Physical Motivation. The latter would be Programmed Physical Motivation or Programmed Physical Consciousness.....Impulsive Physical Consciousness. The former would be Motive-regulated or Conscious Physical programming.....Conscious Physical Impulses. Would it be too much to say that a Stellar nursery was produced out of Love, or Conscious Physical Impulses? Fullerenes fascinate me. They are also produced by ash or soot. This intrigues me because when we sit around a campfire, we become mesmerised by the fire. In Geometrical Thought Harmonics, a Fullerene represents Infatuation. Therefore, being mesmerised by the fire seems to make sense. Also, burning candles produces Fullerenes of Infatuation. Many people light candles when they meditate or are in prayer. Are they in a state of Conscious Love, or Love-regulated Physical Consciousness? Is this a Conscious state of Unconditional acceptance?

Awareness is represented by a centre-point Hexagon, which is a Love-based Sense Agreement. It is also a Conclusive Agreement of focused Imagination, or a Sensory Impulse. In essence, Awareness is an Unconditionally accepted or Impulsive Visualisation. As Emotional Awareness, it is an Impulsively Suggestive Visualisation.

Self-awareness is a product of Emotional Awareness created by Impressions of Attitude and Common Sense. Therefore, it is an Impulsively Suggestive Visualisation of Attitude and Common Sense. Attitude is a Receptive and Constructive Visualisation and Common Sense is an unbiased Visualisation. Attitude is also the position a Body takes in relation to an environment, which is circumstantial surroundings or conditions. Therefore, Self-awareness is an Impulsively Suggestive Visualisation of an environmentallyrelated Self. It is also a product of Emotional Intellect Agreements that form Emotional Logic, which is Suggestive Memory.

Intuition produces Motive-regulated Emotional Awareness that is Impressed by Desire. Therefore, it is Impressed by Impulsively Suggestive Conscious Visualisations. It also produces Emotional Belief and Motive-regulated Attitudinal Behaviour, which is Conscious Nature. Therefore, Intuition Suggests Choices and Personalised Attitudinal Behaviour in response to Desired Awareness, which is in response to Impulsively Suggestive Conscious Visualisations.

Is Love fundamental? What do we mean by that term? In this instance, we are referring to a Principal. In Geometrical Thought Harmonics, a Hexagon represents Love, which is a product of two overlapping Equilateral Triangles of Creative Thought or Imagination. Therefore, the Creative Thought of Imagination is fundamental. Love is an experiential or experience-based form of Imagination or Creative Thought. In context, Imagination would be the first or initial Trait of Mind, which is a design of Thought. Therefore, it would be the first example of Intention or Agenda. In sensory form, Awareness is a product of 6 Equilateral Triangles of Imagination connecting to a centrepoint or Agreement. It is not experiential. It is a Sense Agreement or Sensory Impulse. In both cases, experiential Imagination and Awareness are Creative programs or Impulses. Therefore, Unconditional acceptance is an experiential development. It was not an initial TRAIT – Technique Related Acquired Intentional Thought. It is a Progression of Creative Thought.

In light of that information, the first Trait of Mind had a Creative Intention/Agenda, which is Imagination. The second fundamental Trait of Mind had a Receptive and Constructive Intention/Agenda, which is Intellect. It takes on board and builds upon concepts. Therefore, it accumulates Thoughts. The third fundamental Trait of Mind had a Personal Intention/Agenda of Motive or Consciousness. The fourth fundamental Trait of Mind had an Intention/Agenda of Understanding or Sight, which is Perception. The fifth fundamental Trait of Mind had an Intention/Agenda of Consideration, which is Reflection. The sixth fundamental Trait of Mind had an Intention/Agenda of Realisation, which is Reflection....to make a concept in the Mind Real. They are the six fundamental Traits responsible for Life as we know it. All Senses are products of focused Imagination. They are Creative. All Logic states are products of Intellect. They take on board and build upon concepts. Consciousness is a product of Personal or Motivational Intentions. Time is a by-product of Consciousness. It is Motive-related.

## **Consciously Synchronised Rectification**

Within the Mind or Dream, why is a representation of a Clockface so important? To start with, we have 12 major points of the clock. This represents Synchronicity or Coordination. Then we have the 12 segments of 5 points that create the 60 minor points. This forms 12 Pentagons of Motive, Personal Thought, or Consciousness, 5 Dodecagons of Synchronicity, 15 Squares of Intellect, 10 Hexagons of Love and Awareness, 6 Decagons of Belief, 3 Icosagons of Identity, 4 Pentadecagons of Conscious Imagination, and 2 Triacontagons of Conscious Awareness. Together, they represent Synchronised Consciousness.

In summary, we have the fundamentals of Imagination, Intellect, and Motive that create progressions of those fundamentals, which are Love, Awareness, Belief, Identity, Synchronicity, Conscious Imagination, and Conscious Awareness. However, it does not create Octagons of Morality. Is this significant? If we add 60 seconds to each minute on the Clockface, it would create 3,600 points, which is a product of Octagons of Morality and Hexadecagons of Rectification. This forms Morally Synchronised Consciousness, or Consciously Synchronised Rectification.

Rectification is a product of Experiential Morality. A simple definition of Rectification would be correction. Therefore, as Morality is experiential Judgement, a product of Experience-based Intelligence, it makes corrections according to what has been learnt from the accumulation of experience. Synchronised Rectification would make Coordinative corrections according to what has been learnt from the accumulation of experience. Consciously Synchronised Rectification would make Coordinative corrections according to what has been learnt from the accumulation of experience. In essence, it would be a Coordinated Restructure or Reformation of Consciousness.

# **Rejuvenation – Transmutation – Regeneration.**

Rejuvenation is when something is brought back to its original state. Transmutation is when something is changed into something else. Regeneration is when something is recreated, created again. Healing is a product of Rejuvenation. Evolution is a product of Transmutation. Reincarnation is a product of Regeneration.

ALKAMIRR is an acronym for Advanced Life Kinetics And Memory Intuited Regenerative Research. Kinetics is to do with Motion, the mechanisms for effecting change. In this case, it is the mechanisms for effecting advancements to Life. Therefore, it would relate to the mechanisms that effected Evolution. In essence, Memory Intuited would relate to Memory-related Guidance. Regeneration is when something is recreated, created again. Research is investigation. Therefore, Memory Intuited Regenerative Research would relate to recreating or recalling something from Memory. In this instance, regarding Advanced Life Kinetics, it would be remembering the mechanisms of Evolution, or recreating the circumstances or conditions for Advancement of Life.

#### Ascension

Ascension, as a New Age or Spiritual term, is usually related to moving into or gaining a Higher state of Consciousness. In Religious terms, it could relate to a Heavenly state. It could also relate to Metamorphosis, which is a product of Transmutation.

In Geometrical Thought Harmonics, Metamorphosis is a product of Belief-polarised Emotional Logic, a Belief-polarised Emotional Intellect Agreement, which is Affirmation. Intuitive Metamorphosis is a product of Affirmative Nature Agreements, which are Attitudinal expressions of Affirmation. In context, an Attitudinal expression of Affirmation would be the position a Body takes in relation to a Beliefpolarised Agreement that has been Suggestively taken on board and built upon. Affirmations are Beliefpolarised Agreements that have been Suggestively taken on board and built upon. In other words, they are Experience-based Conscious Agreements that have been Suggestively taken on board and built upon. Body is a reflection of Mind, a reflection of our Thoughts. Consciousness is a product of Personal Thought or Motive. Personal Thought is Personal Opinion. Motive is a Personal Intention or Agenda. Does a Higher state of Consciousness relate to better Intentions? Could it relate to better Conscious Visualisations? Could it relate to a better Understanding of how we Visualise our Personal Thoughts? Could that Understanding bring about a better Dream, a so called Heaven on Earth?

Is Ascension analogous to climbing to the top of a hill to get a better understanding of where we are? What is the driving force behind Evolution? Is it adaptation to change? Could it be something else? Many Intelligent people would say it was adaptation to a changing environment. However, an environment is circumstantial surroundings or conditions. Therefore, the environment in question may not be Planetary. It may simply be the changing Thoughts of a Mindstate, or Mindset. Body is a reflection of Mind, which is a Dream. Mindstate and Dreamstate are synonymous. Mindscape and Dreamscape are synonymous. Is there a difference between Dreamstate and Dreamscape?

A Mindstate is the condition of a Mind. A Dreamstate is the condition of a Dream. A Mindscape is an interpretation of the Mind. A Dreamscape is an interpretation of the Dream. What is the difference between a condition and an interpretation? A condition is a particular state of something. An interpretation gives a description or detailed account of something.

Have Humans halted their own evolution? Our way of adapting to a changing environment is to create external things to compensate for the changes e.g. clothing, shelters, and machines etc. Our Avatars don't seem to change in accordance with environmental variables. In essence, we aren't compatible with this environment.

If we didn't manifest from this Planetary Mindscape or Dreamscape, but from somewhere else in the Universal Dream, it could explain why we haven't evolved in accordance with the Planetary changes. If this is correct, we will need to evolve of our own accord. In this frame of Mind, we will either need to change the environment or change ourselves so the environment will not be harmful. The concept of Interaction comes into play. It allows an entity to influence and be influenced by an environment through experience.

We are definitely influenced by the environment Emotionally, or Suggestively, but in our case we Mentalise the Emotions in a different way to the other creatures within this Dreamscape. They adapt to environmental Suggestions by altering their Bodily structure or functions. We adapt to environmental Suggestions by creating new technology so our present Bodily structure or functions won't be adversely affected. This is not sustainable. Without our external forms of protection, we are extremely vulnerable. What is Evolvability? In essence, it would be the ability to Evolve. In Geometrical Thought Harmonics, it is presented as Identity-polarised Emotional Logic, which is an Identity-polarised Emotional Intellect Agreement. When Attitudinally expressed, it forms an Evolvability Nature Agreement, which is an Agreement of Nature to Evolve.

A combination of 6 Evolvability Nature Agreements forms a Personality-expressed Identity Mind. Therefore, Identity-polarised Attitudinal Behavioural Logic is expressed through the Identified Attitudinal Behaviour of Personality, which is a Personal Reality. In context, it is an Agreement for Personal Reality to Evolve. To be more precise, it is an Agreement for Conscious Reality to Evolve.

An Identity Mind has 10 Logic states formed by the intersecting edges of 10 Octahedrons of Nature that create the Evolvability Nature Agreement. Those 10 Logic states are Attitudinally expressed to form the Attitudinal Behavioural Logic of an Identity Mind.

If we have the ability to Evolve our Conscious Reality, or the Conscious Dream, how do we activate that ability? Is it an automatic response to our changing Thought processes? Considering that the Emotional Logic of Evolvability is a progression of Affirmations, Identity-polarised Affirmations to be precise, does it depend upon what we have Affirmed, what has been asserted, validated, or confirmed?

## Reincarnation

As previously stated, Reincarnation is Regeneration, to recreate something, to create it again. In some circles, Reincarnation is defined as rebirth. However, rebirth would mean to recreate the same entity. If a different Body was created, it would mean that the Mindstate that manifested that Body would be a different one. Body is a reflection of Mind!

From what we have determined, or from what we have observed, our Body does not change dramatically in accordance with a different way of Thinking. Our Understanding of what we are can change dramatically, and our Behaviour can change dramatically, but our Body does not. One Theory could be that an accumulation of experience within a particular Body could initiate the Reincarnation of that changed Mindstate into a Body that reflected the changes. This seems to make sense. The Body would not evolve within the same Lifespan. A new Body would be created with a different Lifespan. If this were the case, Memories of a previous Life could be retained.

Another Theory could be that we don't Reincarnate, but simply access Memories from the Universal Mind that reflect our way of Thinking. They would not be our Personal Memories from a previous Life. However, we could Believe that they are our Personal Memories and declare ownership. Declaring ownership of other people's resources seems to be something that we like doing. In context, Universal Memory is an accumulation of All Thoughts, and the Universal Mind is our Mind. Therefore, all Thoughts are essentially our Thoughts. Declaring Memories to be the property of only One Personality of an infinite number of Personalities of the One Mind is an unfortunate delusion created by a limited Awareness of what we are. The only way to solve that problem would be to advance our Awareness of what we are, what the Mind is, and how the Dream of Life evolves.

Regarding the former Theory, if a Mindstate reincarnated with a different Body, would it be Transmutation rather than Regeneration? If Regeneration is to create something again, and Transmutation is to change something into something else, a Mindstate that manifested a different Body would be through Transmutation or Transformation.

Karma is a well-known concept. In essence, but not necessarily in accordance with popular Belief, Karma is simply cause and effect. Therefore, if a Mindstate changes its way of Thinking, and a new Body manifests in accordance with or as a reflection of that way of Thinking, it would be a product of cause and effect.

### **Well Being**

Through Life, our Bodily state changes according to our Thoughts. If we have disharmonious Thoughts, we create disease. If we have harmonious Thoughts, we create a state of Wellness. However, it isn't just about disease and wellness. Our Body changes in accordance with the work it is expected to perform. Muscle mass expands and our bones strengthen when subjected to extreme work.

Body builders subject their Bodies to extreme work. Rock climbers do something similar. However, they don't expand upon muscle mass. They strengthen their Bones and tendons, and at the same time they tone their muscles for a more streamlined Body rather than a massive Body. Grip strength is their most sought after improvement.

Are those changes related to Transmutation? Improving upon a retained Bodily structure is different to Transforming the Body into something entirely different e.g. from Human into something not Human. If they are not related to Transmutation, what are they related to? It isn't Rejuvenation because that would be making something new again. It isn't Regeneration because that would be recreating something that once existed. What would we call improving upon what we already have?

Advanced Life Kinetics was explained previously. However, could it mean improving upon what we already have? Kinetics is to do with the study of motion and the forces that influence motion. In this case, it could be the study of Life and the forces that influence the advancement of Life.

In essence, Motive is the force that influences the advancement of Life. Motive is a Personal agenda or Personal intention, Conscious agenda or Conscious intention. Therefore, we improve upon what we already have by wishing for something to improve. A Wish is a Desire, which is Motive-based focused Creative Thought. In context to the heading "Rejuvenation – Transmutation – Regeneration", Desire would be the force behind all of those processes......a Physically Creative expression/impression of Personal Intention.

### **Personality-expressed Evolvability**

Personality is Identity-based Attitudinal Behaviour or Nature. Evolvability is an Identity-polarised Emotional Intellect Agreement. Identity is a product of experiential Intelligence and experiential Motivation in the form of Belief. Therefore, Personality-expressed Evolvability would be the ability to evolve a Personality, or Personal Reality. In context, Personality-expressed Evolvability is a product of Evolvability Nature Agreements that form an Identity Mind of Individuality.

Belief-polarised Logic is a Practical Logic state of the Actuality Mind. It is a product and expression of experiential Desire, which forms Agreements of Belief-polarised Desire. What is Belief-polarised Desire? Belief is a declaration of Personal Preference or Choice. It is Preferentiality. Therefore, Belief-polarised Desire is an Agreement of Preferentiality-polarised Desire.

Belief-polarised Logic is an Agreement of Desired Choices, and an expression of Desired Choices. Identity-polarised Belief Logic is a Practical experiential Logic state within the Identity Mind of Individuality, which is Identified Actuality. It is an Agreement of Desired Identity, and an expression of Desired Identity.

Intellect takes on board and builds upon concepts. Identity is a product of Conscious Intelligence, which takes on board and builds upon Personal Thoughts or Intentions in the form of Beliefs. Therefore, Identity-polarised Belief Logic is an Agreement of Identified Desires that have been taken on board and built upon to form Memory. That Memory is expressed through Desire, which is Conscious Visualisation. In context, Identity-polarised Belief Logic would be Consciously Visualised Memory of Identity. Evolution, in general, is a process of change to bring about a better utilisation of resources. Those resources may include environmental and Personal resources, as in the Potential to Visualise Personal Thoughts into the Dream of Life. This would include the Potential to Evolve a Dream Body, a Personal Reality, which in mainstream terms would refer to a Lifeform.

## **Mutual Respect-expressed Harmony**

Respect-expressed Tolerance is a product of Tolerant Nature Agreements that create an Awareness Mind. Mutual Respect-expressed Harmony is a product of Harmony Nature Agreements that create a Synchronicity Mind.

If an Awareness Mind becomes Personalised or Motive-regulated, it creates a Virtuality Mind, which is a Subconscious Awareness Mind. If a Synchronicity Mind becomes Personalised or Motive-regulated, it creates a Commonality Mind, which is a Subconscious Synchronicity Mind. In essence, a Commonality Mind is a Synchronised Virtuality Mind.

Initially, an Awareness Mind is Unconscious or Impersonal. When it becomes Personalised, it becomes Subconscious or Personally programmed, which creates Motive-regulated Reflex Responses or Impulses. A Synchronicity Mind is initially Unconscious or Impersonal. When it becomes Personalised, it becomes Subconscious or Personally programmed, which creates Motive-regulated Reflex Responses or Impulses. If Evolvability is the ability to Evolve a Personality or Personal Reality, what would Evolve a Commonality or Common Reality? In other words, how would we Evolve all Personalities or Personal Realities within a Commonality or Common Reality?

Life as we know it is what we could call a Common Reality or Common Logic Reality. Why would we call it a Common Logic Reality? Common Logic is an Agreement of Common Sense. Essentially, it forms a Common Mind, a Common Sense expressed Nature or Attitudinal Behaviour.

One of the Identity Mind's Logic states is Identity-polarised Common Logic. One of the Commonality Mind's Logic states is Synchronicity-polarised Common Logic. However, if an Awareness Mind becomes Personalised or Motive-regulated, it creates Instinctual Respect-expressed Integration. Instinct is Personalised or Motive-regulated Common Logic, which is a Virtual Brain. Instinctual Respect is Personalised or Motive-regulated Respect, which becomes a Faith-related product of Instinct or the Virtual Brain. Integration is Personalised or Motive-regulated Tolerance.

Virtuality is a Personalised or Motive-regulated product of Common Logic and Awareness Logic, which becomes an Altruistic product of Instinct. In essence, Instinct, or the Virtual Brain, is a form of Guidance. It is a Personalised Guidance of Common Memory.....a Personalised Common Mind.

Altruism is an unselfish or caring mannerism. Therefore, an unselfish or caring product of Instinct would be to help or Guide others. If this were the case, Virtuality would be an all-encompassing form of Visualised Guidance. Therefore, Synchronised Virtuality, or Commonality, would be an allencompassing form of Coordinative Visualised Guidance.

In dictionary terms, Commonality has been defined as sharing something in common. It is synonymous with 'similarity'. In essence, Commonality could relate to a shared Mind or Dream that we have accepted to be Life. Therefore, through Interaction we can influence and be influenced by that shared Mind or Dream.

Is there a particular Logic state of a Commonality Mind that could enable a Personality to alter the shared Mind or Dream? Is it Common Logic, which forms a Common Mind or Common Dream? Could it be Personalised Common Logic, which forms Instinct or the Virtual Brain? Does a Virtual Brain create a Personalised Common Mind or Personalised Common Dream? What would be another name for a Personalised Common Dream? In essence, Instinct is Personalised Common Sensory Memory. Common Sense categorises and Visualises Common Memory. It labels, recognises, and recalls Common Memory. Changing the subject for a moment, the backbone of DNA is formed by Tetrahedron Pyramids of Common Sense. Do they label, recognise, and recall Common Memory? In other words, do they symbolise a Visualisation of Common Memory?

Getting back to the Virtual Brain, Common Logic is Common Sense expressed Nature, which is Common Sense expressed Attitudinal Behaviour. Instinct is Common Sense expressed Intuitive Nature. The overlapping edges of the Tetrahedron Pyramids of Common Sense create the diagonals of Squares of Intellect. Those Squares of Intellect create 5 Cubes of Common Logic rotated around a common vortex. The overlapping edges of the Tetrahedron Pyramids within the Cubes of Common Logic, other than the diagonals, create the points of 2 Logic states. The overlapping edges of the 5 Cubes of Common Logic create 1 Logic state. The overlapping edges of the Cubes change the Pentagon facets of the Dodecahedron of Instinct into Pentagrams, which are Interpretations of Motive. The former Logic states are Personal Conscience and Social or Environmental Conscience. The latter Logic state is Language and Species Differentiation.

Personal Conscience is a product of experiential or Belief-polarised Mental Motive Logic Interpretations. Social or Environmental Conscience is a product of experiential or Love-polarised Creative Logic Applications. Language and Species Differentiation is a product of experiential or Belief-polarised Practical Motive Logic Applications.

If we use the 12 Pentagon external facets of a Dodecahedron of Instinct as bases of Pentagon Pyramids of Desire that are directed inwards, the internalised Pyramid apexes form an Icosahedron of WILL at the centre of the Dodecahedron of Instinct. In combination, we have Will, Intuition, Personal Conscience, Social or Environmental Conscience, Language and Species Differentiation, and Instinct, which form a Virtual Brain Mind or Instinctual Mind.

Within a Virtual Brain Mind, WILL is created by the impressed Desires of Instinct. Personal Conscience and Social or Environmental Conscience become products of Instinct's Common Sense, which become Diversions to the Agreement of Intuition. Language and Species Differentiation becomes a Motive Interpretation of Instinct's Common Logic.

#### **FEAR**

As an acronym, FEAR stands for Form Experienced/Expressed Amnesia Reaction. It has been proposed that together, Personal Conscience and Language and Species Differentiation can result in Fear. Why? Language and Species Differentiation is a Belief-polarised experiential Practical Motive Logic Application that eventuates as the result of the Belief-polarised experiential Mental Motive Logic Interpretation of Personal Conscience. Both Logic states produce a Belief Mind of Actuality. "Virtuality became Actuality and imprisoned the Mind". Instinct is a Virtual Brain. It produces Virtuality. Social or Environmental Conscience also produces Virtuality. Intuition can produce Virtuality and Actuality because it is a product of Emotional/Suggestive Awareness and Emotional/Suggestive Belief. It Suggests Choices and Personalised Attitudinal Behaviour in response to Desired Awareness. What produces Amnesia? In essence, it can be a loss of Memory or an inability to access Memory that was once accessible. I Think the latter is more likely. I don't Think we ever lose Memory. It would be more likely for Memory to become inaccessible. If so, how would Memory become inaccessible? As previously stated, Personal usually means Private. Therefore, Common Memory could become partitioned or Personalised due to an infinite number of Personalities Wishing for privacy within a Shared Mind or Dream. Could that cause Amnesia?

As previously stated, Amnesia is usually a loss of or inability to access Memory that was once accessible. However, it usually relates to Memory of Personal experience. Motive Logic is Personal or Conscious Memory. Therefore, the Belief-polarised Mental Motive Logic Interpretation of Personal Conscience and the Belief-polarised Practical Motive Logic Application of Language and Species Differentiation are examples of Personal Memory.

Instinct is Personalised Common Memory. When we Personalise something, we make it more suitable to our Preferences. Belief is a declaration of Personal Preference or Choice. Sometimes, Personalisation can mean that we Choose what we want to keep from a number of existing items, and accumulate other items that reflect our Preferences. It becomes a declaration of Personal Preference or Choice. The term 'items' could relate to anything that exists. Could it relate to Memory?

Is there a difference between Personal and Personalised? If Personal means Private, then Personalised could mean to make something Private. Therefore, the Common Logic or Common Memory of Instinct would be made Private or Personal. If Instinct is a Virtual Brain, it would be made Private or Personal. In the Dream of Mind that we have Believed to be Life, it could manifest as an Actual BRAIN – Body Related Active Intelligent Nemesis. In this regard, Nemesis could mean 'cause and effect'. The acronym of BODY means Being Of Direct Yield. The acronym of BEING means Brain Expressed Intelligent Natural Guise. If this is so, a BODY could be a reflection of a Virtual Brain Mind, or Instinctual Mind, with 6 controlling Mindstates......WILL, Intuition, Personal Conscience, Social or Environmental Conscience, Language and Species Differentiation, and Instinct. Intuition Suggests Choices and Personalised Attitudinal Behaviour in response to Desired Awareness.

The acronym of MIND means Mediative Instructional Nature Delegation. 'Delegate' means to assign, allocate, or represent something. In this case, a BODY could represent the Attitudinal Behaviour of Nature. Attitude is the position a Body takes in relation to an environment.

In context, FEAR is a product of Belief, which is a product of experiential Consciousness. In essence, Belief is an experience-based Personal Agenda. Choice is an experience-based Personal Agenda, a declaration of Personal Preference. Logic simply accumulates and categorises concepts to form Memory. In the case of Personal Conscience, which is a product of Belief-polarised experiential Mental Motive Logic Interpretations, it would Interpret experiential Personal or Conscious Memory. In the case of Language and Species Differentiation, which is a product of Belief-polarised experiential Practical Motive Logic Applications, it would Apply experiential Personal or Conscious Memory. Therefore, FEAR could manifest according to how our Conscious experiences are Interpreted.

What is Personal Conscience? Let's break it down. Science is an investigation into and observation of environmental factors.....the interpreted knowledge obtained from investigation and observation. 'Con' means with. Therefore, Conscience is an accumulation of Interpreted knowledge. In essence, it is a generalisation. In other words, a state of Conscience would be determined by the subject e.g. Moral or Personal etc. This would include Conduct Conscience and Habit or Comfort Conscience.

As previously stated, Personal can mean Private and Conscious. It can also relate to Motive, which is a Personal Agenda. In context, Personal Conscience is Belief-polarised. Therefore, it would be an accumulation of Belief-interpreted Personal experiences within an environment. Belief is the crucial factor that would determine the conditioning of Personal Conscience.

Superstitions would relate to an accumulation of Belief-interpreted Personal experiences within an environment. They are usually based upon FEAR, which is a product of limited information and lack of Awareness.

Could Amnesia be a consequence of Fragmentation? What is Fragmentation, and what does it usually refer to? Usually, Fragmentation infers that something has become divided or disconnected. Regarding computers, it usually means that information has become separated from its categorical designation. This would make information difficult to access. In essence, it could produce computer-related Alzheimer's. Initially, and in its mildest form, it could slow down the ability to access Memory. At its worst, it could prevent access completely through an exponential state of confusion.

Is FEAR a state of confusion caused by a Fragmented or Partitioned Mind? Regarding computers, we can create Logical or Virtual Partitions within a Drive that houses an Operating System. The Hard drive would be regarded as Physical and the Logical Partitions would be regarded as Virtual. However, within a Mind, Logic can be Emotional, Mental, and Physical. In essence, Physical would be regarded as Practical, Emotional would be regarded as Suggestive, and Mental would be regarded as Interpretative. In context, it would relate to Hypothetical, Theoretical, and Practical Logic. In Dream language, Physical would simply mean made manifest into the Awake Dream, the Virtualised Environmental Construct.

#### Reality

Reality is simply a concept in the Mind that has been Imagined e.g. Virtuality or Virtual Reality, Actuality or Actual Reality, Personality or Personal Reality, Commonality or Common Reality, Cordiality or Cordial Reality, Individuality or Individual Reality etc. Virtuality is Awareness-based. Actuality is Belief-based. Personality is Identity-based. Commonality is Synchronicity-based. Cordiality is Moral-based, and Individuality is Identity-based.

Environment is circumstantial surroundings or conditions. In essence, it is a concept in the Mind that has been Imagined. A Virtualised Environmental Construct is a concept in the Mind that has been Sensed through Awareness. However, it has not been Believed to be Actual. If Believed to be Actual, it becomes an Interactive Visualisation of Conscious Thought. In that state, an Entity could become embedded into a Consciously experienced Sensory Environment. If an Entity created Methodologies regarding what that environment is or how that environment came about, it could become governed by those Methodologies. Therefore, the Dream of Mind could become a Symbolic reflection of Restricted Interpretation. Unfortunately, we have accepted a Symbolic reflection of Restricted Interpretation to be Life. "Virtuality became Actuality and imprisoned the Mind". An Imagined environment became a Believed environment and imprisoned the Mind. The Personalities of Mind Identified with that Symbolic reflection of Restricted Interpretation and called it Home. We now exist within a Self-perpetuating Dream that we are all supporting through an ignorant manifestation of Personal and Competitive Thinking. Evolution has become an adaptation to that ignorant manifestation of Personal and Competitive Thinking. In essence, it has become a Revolution rather than Evolution. To be more precise, we have been Revolting against our own 'cause'.....against a Self-perpetuating Dream that we all helped to create through our Ignorance of Creative Potential, the Creative Potential that we have all wielded through our Wishes, Prayers, or Desires. "Ask, and you shall receive". "We are what we Think". "Thought is the beginning of all creation". "As we Think, we shall become". "Be careful what you Wish for, because you might just get

it". "The road to Hell can be paved by good intentions".

"Ignorance is Bliss"? That statement was created by people who didn't Wish to take responsibility for what they had created. Ignorance is not Bliss! It is simply a product of limited information, and a lack of Awareness as to what we should do with the information we have. "Know your SELF".

If we became Aware of our Creative Potential, and also Aware of how Impulsive our Thoughts can be, could we develop a Fear of Manifesting Personal Thoughts?

Thought is a response to and an Opinion of an environment. Our responses can become programmed through repetition. Therefore, we can develop Reflex Responses or Impulses that correspond to certain situations, circumstances, or conditions.

Survival Instincts can be programmed. Instinct is Personalised Guidance of Common Memory or Common Logic. What would be an example of Common Logic or Common Memory? A Common Logic Reality is an example. This means that all inhabitants of a Common Logic Reality would have Common Sensory Memory. They would recognise the same Reality. They could also be governed by Common Methodologies and Environmental elements e.g. Gravity, a need to be sustained by consuming Energy, and a need to be protected from the elements etc. They could also be territorial and Feel threatened by unrecognised or unwelcome visitors. This could instigate competition and conflict.

If a Reality existed where all entities within that Reality automatically manifested their Thoughts into the Dream of Life without the barriers of Time, and those entities were suffering from the same 'disconnect' as us, a chaotic and warlike Reality could manifest. It would only be Natural for those entities to eventually FEAR their own Potential.

Could it be possible that an Agreement of Attitudinal Behaviour was initiated that restricted the manifestation of Thoughts through a Time-governed process? Certain criteria would have to be met before those Thoughts could be Visualised into the Dream of Life. If that were the case, some Thoughts

could manifest earlier than others. In the same Tone, some Thoughts may never manifest because they may not meet the criteria. What could the criteria be?

Could a group Mentality have been initiated? This would mean that a certain number of Personalities would need to come on board for the Thought/Energy to become powerful enough to overcome the barriers of TIME – Thought-Intention-Motivation-Expression. This could include the Quality or Intensity of the Thought, the Intention of the Thought, the Motive behind the Thought, and the form of Expression to bring the Thought into fruition. If all of those criteria were met, the Time barrier could be overcome. If a vast number of Personalities Agreed with a certain way of Thinking, the Dream of Life could be influenced dramatically. Was this the purpose of Politics, which is the art and science of influencing and controlling others? Could it also have initiated Democracy, a disguised Political endeavour, which is simply Majority-rule, another form of Dictatorship?

Are we ready to take responsibility for what we Create, and consider the needs of the Whole as more important than our Selfish wants?

In Hindsight, a TIME-governed existence hasn't really changed anything other than taking longer to stuff everything up. The end result is still the same because a 'disconnect' still exists. What will it take for all Personalities to Unite with a Common purpose to create a better Virtual world?

## **Attestation and Attenuation**

As previously explained, Language and Species Differentiation is a product of Belief-polarised Practical Motive Logic Applications, which is a Motive Interpretation of Instinct's Common Logic. Initially, Language and Species Differentiation was described as Attenuation, which is a form of Restriction. Also, as previously explained, Social or Environmental Conscience is a product of Love-polarised or Experiential Practical Creative Logic Applications, which is a Diversion to the Agreement of Intuition as part of the Virtual Brain-mind. Initially, it was described as Attestation, which is to validate something as true, correct, or genuine.

In the Virtual Brain-mind, Instinct is an expression of Common Sense Agreements, which are Common Sense expressions of Intuitive Nature. Those Common Sense expressions create, by their intersecting Lines of Thought, Personal Conscience and Social or Environmental Conscience as Diversions to the Agreement of Intuition. Therefore, before becoming the Guidance of Instinctual Memory, Intuitive Guidance must be filtered through those two forms of Conscience.

Personal Conscience, as previously stated, is a product of Belief-polarised Mental Motive Logic Interpretations. It is Belief-interpreted experiential Personal or Conscious Memory, which is the first filter or Diversion. It is then passed on for Attestation through the Personalised experiential Creative Logic of Social or Environmental Conscience. Once it is validated, it becomes Instinct. However, the Personalised Common Logic of Instinct produces an Interpretation of Consciousness labelled as Attenuation, which produces Language and Species Differentiation.

Did this process restrict our ability to manifest Thought instantaneously into the Dream of Mind? In essence, a Virtual Brain-mind seems to reflect a partitioned or fragmented Mind. If so, was it intentional or consequential?

#### Insight

In Geometrical Thought Harmonics, Insight is represented by a 21 point polygon – a Icosikaihenagon. To create a Nature Agreement from Insight we must double this polygon to create two overlapping or interactive Icosikaihenagons. This becomes a 42 point polygon, which is a Tetracontadigon. The Icosikaihenagon is a product of 7 overlapping or interactive Equilateral Triangles of Creative Thought or Imagination and 3 overlapping or interactive Heptagons of Perception. Therefore, it is Perception of what has been Created – Perceptive Imagination or Creative Perception. The 42 point polygon is a product of 7 Centre-point Hexagons of Awareness, 6 Heptagons of Perception, 3 Tetradecagons of Hindsight, and 2 Icosikaihenagons of Insight – Perceptive Awareness, Experience-based Insight, or Peripheral Awareness. In essence, it is Hindsight-based Insight.

What would we call an Emotional Logic state that was polarised by Peripheral Awareness? Also, what would we call a Feeling state that was a product of Peripheral Awareness?

Peripheral Awareness allows us to see the big picture, which means that we are not just focused on what is in front of us. As said, it is a product of Insight and Hindsight. Therefore, it is Perception of what and how something has been created based upon or influenced by what has been gained from an understanding of the past.


The 7 overlapping centre-point Hexagons of Awareness that form the 42-point polygon of Peripheral Awareness allow us to Visualise past and present happenings. The 14 overlapping Equilateral Triangles of Creative Thought or Imagination give us the experiential Imagination of Insight. The 6 overlapping Heptagons of Perception give us the experiential Perception of Hindsight. The many Grammic forms of Perception, Insight, Hindsight, and Perceptive Awareness Interpret what has been visualised.

'Gram' means something written or recorded, as in a message, translation, or interpretation. Therefore, Grammic forms give Interpretations of polygonal designs of Thought e.g. Heptagrams interpret the Heptagons of Perception, Tetradecagrams interpret the Tetradecagons of Hindsight, Icosikaihenagrams interpret the Icosikaihenagons of Insight, and Tetracontadigrams interpret the Tetracontadigons of Perceptive Awareness.


Peripheral Awareness-based Feeling is a product of Awareness-based Feeling of Respect and Hindsightbased Feeling of Retrospection. In simplicity, it could be Retrospection-based Respect or Respect-based Retrospection. Peripheral Awareness-polarised Emotional Logic is a product of Awareness-polarised Emotional Logic of Tolerance and Hindsight-polarised Emotional Logic of Probability. In simplicity, it could be Tolerance-based Probability or Probability-based Tolerance. In combination, it is a product of Respect-based Tolerance and Retrospection-based Probability.

As a Nature Agreement, and forming a Mindstate, a Peripheral Awareness-based Mindstate would have 21 Logic states and a Peripheral Awareness-based Feeling state. The first Logic state is the Peripheral Awareness-polarised Emotional Logic that is a product of Tolerance and Probability. The next Logic state is 2 overlapping Insight-polarised Mental Logic Interpreters. Then we have a Peripheral Awareness-polarised Mental Logic Interpreters, Then we have a Peripheral Awareness-polarised Mental Logic Interpreter, 2 Insight-polarised Mental Logic Interpreters, another Peripheral Awareness-polarised Mental Logic Interpreters, 14 Creative Logic Applications, another Peripheral Awareness-polarised Mental Logic Interpreter, 6 Perception-polarised Mental Logic Interpreters, another Peripheral Awareness-polarised Mental Logic Interpreters, 6 Perception-polarised Mental Logic Interpreters, another Peripheral Awareness-polarised Mental Logic Interpreters, 2 Insight-polarised Mental Logic Interpreters, 3 Hindsight-polarised Mental Logic Interpreters, 2 Insight-polarised Mental Logic Interpreters, 3 Hindsight-polarised Mental Logic Interpreters, 2 Insight-polarised Mental Logic Interpreters, 3 Hindsight-polarised Mental Logic Interpreters, 2 Insight-polarised Mental Logic Interpreters, 3 Hindsight-polarised Mental Logic Interpreters, 2 Insight-polarised Mental Logic Interpreters, 3 Hindsight-polarised Mental Logic Interpreters, 2 Insight-polarised Mental Logic Interpreters, 3 Hindsight-polarised Mental Logic Applications, 6 Perception-polarised Practical Logic Applications, another Peripheral Awareness-polarised Mental Logic Interpreter, 2 Insight-polarised Mental Logic Interpreters, 3 Hindsight-polarised Practical Logic Applications, 2 Insight-polarised Practical Logic Applications, and a Peripheral Awareness-polarised Practical Logic Applications.

The picture below shows Peripheral Awareness-based Feeling in combination with the Peripheral Awareness-polarised Nature Agreement.



The picture below shows the 21 Logic states created by the overlapping edges of the 21 Octahedrons of Nature that form the Agreement.



Peripheral Awareness is commonly accepted to be Aware of more than what is normally Perceived. Peripheral Vision is commonly accepted as being able to see to the sides as well as what is in front. However, Peripheral Awareness is a product of Hindsight and Insight. Therefore, it is the ability to reconstruct Memories, and to understand the Thinking that manifested the Dream of Life.

What do we mean by reconstruct Memories? Rejuvenation is a reconstruction of Memory. It uses Memory to bring something back to its original state. Therefore, Healing can be performed by using the Hindsight-based Insight of Peripheral Awareness. Also, when we understand the symbolism of the Dream, we can alter the Thinking that caused something to manifest. When the term "Body is a reflection of Mind" is understood, we can create a better us, and a better world.

Within the Mind, what do the eyes represent within the Body? If Body is a reflection of our Thoughts, and Perception is the way we see something, or a form of understanding, are the eyes a manifestation of Perception? If so, why do we have two?

Duality is an interesting concept or term. There are many different ideas on what Duality refers to. In essence, it refers to the terms "I am that I am" and "I am that I choose to Be". This refers to our Essence, which is "Pure Potential", an infinite source of possible Thoughts, and our seemingly separated Identities, which are an accumulation of Personal Preferences, Beliefs, or Choices....our Personal Realities or Personalities.

Peripheral Awareness allows us to merge the Awareness of the Source and the Awareness of the SELF – Source Expressed Life Form.

Peripheral Awareness-based Feeling Suggests Peripheral Awareness-based Behaviour, which is an 'Expression' of what has been Suggestively taken on board and built upon through the Perception of a "Source Expressed Life Form". Peripheral Awareness-polarised Emotional Logic is an 'Agreement' of what has been Suggestively taken on board and built upon through the Perception of a "Source Expressed Life Form". A Peripheral Awareness-polarised Nature Agreement is an Agreement and Expression of Attitudinal Behaviour that has been Suggestively taken on board and built upon through the Perception of a "Source Expressed Life Form". SELF can also refer to a 'Sentient Expressed Life Form', a 'Sensory Expressed Life Form', and a "SOUL Expressed Life Form", which is a "State Of Unified Love Expressed Life Form".

When we completely understand what we are, we behave in a manner that reflects and defines a "Source Expressed Life Form"......a "SOUL Expressed Life Form".

Insight-polarised Self-awareness is a product of 7 interactive Cuboctahedrons of Self-awareness forming polar 21-point polygons of Insight from the Equilateral Triangle facets. The centre-point Hexagon Emotional planes of the 7 Cuboctahedrons form the 42-point equator of Peripheral Awareness. Peripheral Awareness-polarised Self-awareness is a product of 14 Cuboctahedrons of Self-awareness forming polar 42-point polygons of Peripheral Awareness from the Equilateral Triangle facets. The centre-point Hexagon Emotional planes of the 14 Cuboctahedrons form an equator of 7 overlapping centre-point Hexagons to form the 42 points of Peripheral Awareness. 7 of those centre-point Hexagon Emotional planes are shared. That is why it only creates a 42-point equator instead of 14 centre-point Hexagon planes creating 84 points.

If two Cuboctahedrons of Self-awareness are combined to form polar Hexagram planes, it forms a Cubic Close Packed atomic structure combined with a Hexagonal Close Packed atomic structure. The Hexagonal Close Packed structure represents Self-assessment. The Cubic Close Packed Cuboctahedron represents Self-awareness. Therefore, it creates a Self-assessing Self-awareness.

When we take the 8 Equilateral Triangle external planes of a Cuboctahedron and add 4 more Cuboctahedrons rotated around the same vortex centre, the 8 Equilateral Triangle planes become Hexagram planes. It becomes a product of Self-assessing Self-awareness and forms Introspection, which is to examine one's own Thoughts and Feelings. When we add 48 more Cuboctahedrons to that 5 and
