

LABYRINTH OF MIND

Exposé of Unconsciousness

Pure Potential is an infinite source of possibilities, which could be regarded as Unconscious Potential or Unconsciousness. It manifests Thought in response to an environment, which is a condition, situation, or circumstance.

Designs of Thought have agendas or intentions e.g. Imagination has a Creative intention. Intellect has a receptive and constructive intention. Motive has an intention of incitement or incentive. Love has an intention of unconditional acceptance. Morality has an intention of experiential judgement. Belief has an intention of choice or declaring preference. Identity has an intention of receptive and constructive preferentiality.

An accumulation and categorisation of Thoughts is structured Memory. It forms a Mind.

Mind Unconscious

MIND, a Mediative Instructional Nature Delegation, is a Sensory and Logical Entity with a particular behaviour. It processes Feelings and Senses into Logic states, which are Libraries Of Growing Intelligent Concepts.

An Unconscious Mind would be an impersonal Sensory and Logical Entity with an impersonal behaviour. Both Impersonal and Unconscious implications, in this regard, mean without Motive or Personal Thought.

Sense is focused Creative Thought or Imagination. It labels, recognises, and recalls Memory. Sense can be Emotional/suggestive/hypothetical, Mental/detailed/theoretical, or Physical/experimental/practical. It can be biased or unbiased.

Unconscious or Impersonal Senses would include Common Sense, Intellect-based Sense or Attitude, Awareness, and all progressions and multiples of those Senses that are not Motive oriented.

Logic is a Library Of Growing Intelligent Concepts; encapsulated Intellect. It categorises Memory. Logic can be an Intellectual Agreement formed by Emotional/suggestive/hypothetical Intellect, an Intellectual Interpretation formed by Mental/detailed/theoretical Intellect, and an Intellectual Application formed by Physical/experimental/practical Intellect. It can be unbiased or polarised.

Unconscious or Impersonal Logic would include Creative Logic, Common Logic, Awareness Logic, and all progressions and multiples of those Logic states that are not Motive oriented.

Behaviour is an expression of focused Emotional/suggestive/hypothetical Intellect, which is an expression of Feeling. Feeling can be biased or unbiased.

Unconscious or Impersonal Feeling would include Attitudinal Feeling, an Attitudinal Sensory expression of Feeling, which is Nature, Awareness-based Feeling, which represents Respect, Synchronicity-interactive Attitudinal Feeling and Synchronised Awareness-based Feeling, which represents Mutual Respect, and all progressions and multiples of those Feelings that are not Motive oriented.

Conscious; Personalised Unconsciousness

Motive is incentive or incitement. It is Personal Thought or a Personal agenda. Belief is interactive incentive, or interactive Personal Thought, which is a declaration of preferentiality or choice.

A Conscious Mind is a Motive oriented Sensory and Logical Entity with a Motive oriented or Personalised behaviour. It is a Personal Mind. It processes Personalised Feelings and Senses into Personalised Logic states, which are Conscious Libraries.

Conscious, Personal, or Personalised Sense would include Motive-based Sense, which is Desire, and all progressions or multiples of Desire as well as all Motive oriented or Personalised progressions and multiples of the Unconscious Senses e.g. Common Sense, Attitude, and Awareness.

Conscious, Personal, or Personalised Logic would include Motive-polarised Logic, Belief-polarised Logic, Identity-polarised Logic, and all progressions and multiples of those Personal Logic states. In addition, all Motive oriented or Personalised progressions and multiples of the Unconscious Logic states e.g. Creative Logic, Common Logic, and Awareness Logic.

Conscious, Personal, or Personalised Feeling would include Belief-based Feeling, which represents Trust, Identity-interactive Attitudinal Feeling, which represents Personality, and all progressions and multiples including Motive oriented or Personalised progressions and multiples of the Unconscious Feeling states e.g. Nature, Respect, and Mutual Respect.

Subconscious; Personally Programmed Unconsciousness

A Subconscious Mind is a reflex responsive, impulsive, or programmed Motive oriented Sensory and Logical Entity with a reflex responsive, impulsive, or programmed Motive oriented behaviour; a reflex responsive, impulsive, or programmed Personal Mind. It processes Personally programmed Feelings and Senses into Personally programmed Logic states, which are Subconscious Libraries.

Subconscious Senses would include all Motive oriented reflex responsive, impulsive, or programmed Senses e.g. Motive oriented Awareness; Motive oriented Common Sense programs.

Subconscious Logic states would include all Motive oriented reflex responsive, impulsive, or programmed Logic states e.g. Motive oriented Creative Logic programs; Motive oriented Synchronised Common Logic programs; Motive oriented Awareness Logic.

Subconscious Feeling would include all Motive oriented reflex responsive, impulsive, or programmed Feeling states e.g. Motive oriented Awareness-based Feeling, which is Motive oriented Respect, Motive oriented Synchronicity-interactive Attitudinal Feeling and Synchronised Awareness-based Feeling, which is Motive oriented Mutual Respect.

An Enquiring Mind

Partitions: Actual and Virtual

An enquiry is usually Motive-based, which is incentive or incitement-based. Therefore, it is Personal and Conscious. An Unconscious Mind is Impersonal. If it began a field of enquiry, it could have contradictive Thoughts or opinions. They could initiate Personal/Conscious and Subconscious Partitions of the Unconscious Mind.

If a Mind has similarities to a Computer, it could form Actual and Virtual Partitions. Those Partitions could house Personal Minds, as Partitions on a Computer Hard drive can house Operating Systems.

Actual, in this regard, means Conscious and Belief-based. Virtual, in this regard, means Subconscious and Awareness-based.

An Actual Personal Mind could be a Belief-based Sensory and Logical Entity with a Belief-based behaviour. It could process Belief-based Feelings and Senses into Belief-based Logic states, which are Belief-based Libraries. Belief is a declaration of Personal preference or Choice. Actual Partitions could house Virtual Partitions. Virtual Partitions could house Virtual Personal Minds.

A Virtual Personal Mind could be an Awareness-based Sensory and Logical Entity with an Awareness-based behaviour. It could process Awareness-based Feelings and Senses into Awareness-based Logic states, which are Awareness-based Libraries. Awareness is a conclusive agreement of focused Creative Thought or Imagination, which is an unconditional or Love-based Sense agreement.

If this is possible, an Unconscious Mind could form an infinite number of Partitions, and an

infinite number of Conscious and Subconscious Personal Minds. Personal Minds could be interactive or remain isolated just as Operating Systems on Hard drive Partitions can be interactive or remain isolated.

Virtual Brain-mind

In “Geometrical Thought Harmonics”, Instinct can form Virtual Brain-minds of differing complexity. Initially, a Virtual Brain-mind is a Hybrid of Actual/Conscious and Virtual/Subconscious Personal Mindstates with an Intuitive behaviour. It has Will, Intuition, Personal Conscience, Social or Environmental Conscience, Language and Species differentiation or Attenuation, and Instinct as its fundamentals. A Virtual Brain-mind processes Personalised Feelings and Senses into Conscious and Subconscious Logic states, which are Conscious and Subconscious Libraries.

Will is a construct and expression of Motive-based Sense or Desire, which is a construct and expression of Personal Sense.

Intuition is a construct of Emotional/suggestive/hypothetical Awareness formed by impressions of Desire or Personal Sense, and an Emotional/suggestive/hypothetical Belief-regulated expression of Nature.

Intuitive Awareness is a personalised Sense, and therefore, it is temporary, preferential, and Subconscious, which is a personally programmed Sensory reflex response. It can be ever changing. However, Belief is a declaration of personal preference or Choice. Therefore, it can be rigidly preferred and practiced. If a Belief is rigidly adhered to, Conscious Awareness can orbit that Belief and form a continuous Subconscious Loop. All habits and comfort zones are formed by Belief.

Personal Conscience is a construct of Belief-interactive Mental/detailed/theoretical Motive Logic.

Social or Environmental Conscience (Attestation) is a Motive oriented construct of program-interactive Physical/experimental/practical Creative Logic.

Language and Species differentiation (Attenuation) is a construct of Belief-interactive Physical/experimental/practical Motive Logic.

Instinct is a Motive oriented construct of Common Sense-agreements and Common Logic.

Personal Entities could be products of Virtual Brain-minds with differing complexity. When the fundamentals are internalised, by-products are produced. The interrelationship of the fundamentals and by-products could produce an exponential evolution of Personal Entities, Personal Minds, Personalities, or Personal Realities.

Universal Mind

Unconscious Mind, or Partition of an Unconscious Mind

The known Universe could represent the One and only Unconscious Mind of Pure Potential, or, it could be a Partition of the Unconscious Mind. If it is a Partition, or one of many Partitions, an infinite number of Universal Minds could have formed within the Unconscious Mind of Pure Potential. Therefore, an infinite number of Personal Minds, Actual/Conscious and Virtual/Subconscious, could exist within One Universal Mind or many Universal Minds.

Galaxies could be Virtual Partitions housing Galactic Virtual Minds, and Stars could be the Virtual Mindstates that form a Galactic Virtual Mind. Planets could be Actual Mindstates of a Star’s Virtual Mindstate. Personal Entities could be products of Virtual Brain-minds, Hybrid Actual/Conscious and Virtual/Subconscious Personal Minds of a Star’s Virtual Mindstate and a Planet’s Actual Mindstate.

Behaviour; Feeling

All Minds are initiated by behaviour, an expression of Feeling, which is an expression of focused Emotional/suggestive/hypothetical Intellect. The Attitudinal Feeling or behaviour of Nature is an Attitudinal Sensory expression of focused Emotional/suggestive/hypothetical

Intellect.

Basic or Common Minds are initiated by the Attitudinal behaviour of Nature. They form Unconscious and Impersonal Libraries.

Unconscious Awareness Minds are initiated by Awareness-based behaviour of Respect.

Unconscious Synchronicity Minds are initiated by Synchronised Awareness-based behaviour and the Synchronicity-interactive Attitudinal behaviour of Mutual Respect.

Basic Personal/Conscious Minds are initiated by Intuitive or Personalised Attitudinal behaviour.

Actual Personal/Conscious Minds or Belief Minds are initiated by the Belief-based behaviour of Trust. Faith is a construct of Trust and Will.

Individual Personal/Conscious Minds or Identity Minds are initiated by the Identity-interactive Attitudinal behaviour of Personality.

Subconscious Awareness Minds or Virtual Personal Minds are initiated by the Motive oriented Awareness-based behaviour of Respect. They are Personally programmed Awareness Minds.

Subconscious Synchronicity Minds or Synchronised Virtual Personal Minds are initiated by Motive oriented Synchronised Awareness-based behaviour and the Motive oriented Synchronicity-interactive Attitudinal behaviour of Mutual Respect. They are Personally programmed Synchronicity Minds.

LOGIC:

Agreements, interpretations, and applications

LOGIC is a Library Of Growing Intelligent Concepts. It has Emotional/suggestive/hypothetical, Mental/detailed/theoretical, and Physical/experimental/practical forms.

Emotional/suggestive/hypothetical Logic is an Intellectual Agreement formed by Emotional/suggestive/hypothetical Intellect. It forms Emotional/suggestive/hypothetical Libraries. Mental/detailed/theoretical Logic is an Intellectual Interpretation formed by Mental/detailed/theoretical Intellect. It forms Mental/detailed/theoretical Libraries.

Physical/experimental/practical Logic is an Intellectual Application formed by Physical/experimental/practical Intellect. It forms Physical/experimental/practical Libraries.

Emotional Logic Agreements are suggested by Feeling. Mental Logic Interpretations detail the Suggestions. Physical Logic Applications experiment with the detailed suggestions.

A Common Mind has a Common Sense-agreement suggested by the Attitudinal Feeling of Nature. It has no Emotional/suggestive/hypothetical Logic Agreement. Common Sense expressions form the Mental details of a Common Mind. It has no Mental/detailed/theoretical Logic Interpretation. Common Sense expressions detail the agreement suggested by Attitudinal Feeling. Common Logic is an Intellectual Application that experiments with the expressed Common Sense-detailed suggestions of Attitudinal Feeling.

A Common Entity Mind has the Emotional/suggestive/hypothetical Logic of Self-awareness. It forms a Logic Agreement suggested by the Attitudinal Feeling of Nature. There is no Mental Logic Interpretation. However, the Common Sense Agreements of Common Logic form the Mental details. A Common Logic Application experiments with the impressed Common Sense suggestions and the expressed Common Sense Agreements of Attitudinal Feeling-based Self-awareness.

Interactivity

Interactivity gives an Entity the ability to influence and be influenced by an Environment. What allows an Entity to interact with an Environment?

A Basic or Unconscious Common Mind has no interactive behaviour, interactive Sense, or interactive Logic. A Basic Personal/Conscious Common Mind has no interactive behaviour, interactive Sense, or interactive Logic.

Unconscious and Subconscious Awareness Minds have reflex responsive, impulsive, or program-interactive Creative Logic. Unconscious and Subconscious Synchronised Awareness Minds have reflex responsive, impulsive, or program-interactive Attitudinal behaviour,

program-interactive Creative Logic, program-interactive Common Logic, and program-interactive Awareness Logic. They could also have Synchronised program-interactive Self-awareness.

An Actual Belief Mind has Belief-interactive Motive Logic. An Identity Mind has the Identity-interactive Attitudinal behaviour of Personality, Identity-interactive Common Logic, Identity-interactive Motive Logic, and Identity-interactive Belief Logic.

Entities produced by Unconscious and Subconscious Awareness Minds share interactive Unconscious and Subconscious Creative Libraries. Entities produced by Synchronised Unconscious and Subconscious Awareness Minds have interactive Natures, share Creative Libraries, Common Sensory Libraries, and Awareness Libraries.

Personal Entities produced by Belief Minds share Belief-interactive Motive Libraries. Personal Entities produced by Identity Minds have Identity-interactive Natures or Personalities, share Identity-interactive Common Sensory Libraries, Identity-interactive Motive Libraries, and Identity-interactive Belief Libraries.

A Virtual Brain-mind has the Belief-interactive Mental Motive Logic of Personal Conscience, the Belief-interactive Practical Motive Logic of Language and Species differentiation or Attenuation, and the program-interactive Creative Logic of Social or Environmental Conscience. Therefore, Personal Entities produced by Virtual Brain-minds share Conscious Belief-interactive Motive Libraries and Subconscious program-interactive Creative Libraries. Computer Operating Systems and Software programs can share Libraries, therefore, why not Minds and Mindstates.

If interactivity allows Entities to influence and be influenced by an Environment, and an Environment encompasses all Entities, then we can alter the behaviour of Environmental Entities, and those Entities can alter our behaviour.

Progressive Evolution

When the Unconscious Mind of Pure Potential forms Partitions, Personal/Conscious and Subconscious Mindstates, those Mindstates, and all Entities formed by those Mindstates, can influence one another and evolve according to that influence.

If the Unconscious Mind of Pure Potential was a Common Mind, it could have a Nature or Attitudinal behaviour, Self-awareness, and Common Sense-agreements of Common Logic. If it were an Unconscious Awareness Mind, it would have an Awareness-based behaviour of Respect, Awareness-polarised Emotional/suggestive/hypothetical Logic of Tolerance, reflex responsive, impulsive, or program-interactive Creative Logic, and Physical/experimental/practical Awareness Logic.

If it is an Unconscious Synchronised Awareness Mind, it has Synchronised Awareness-based behaviour and the Synchronicity-interactive Attitudinal behaviour of Mutual Respect, Synchronised Emotional/suggestive/hypothetical Logic of Harmony, Synchronicity-polarised Mental/detailed/theoretical Logic of Synchronicity Conscience, Synchronicity-interactive Creative Logic, Synchronicity-interactive Common Sense-agreements of Common Logic, Synchronicity-interactive Awareness Logic, and Physical/experimental/practical Synchronicity Logic. In this scenario, the Unconscious Mind of Pure Potential could interact with, and automatically respond to, all Conscious and Subconscious Mindstates.

Did the Unconscious Mind of Pure Potential evolve from a Common Mind to an Awareness Mind and then to a Synchronised Awareness Mind, or, is it still evolving toward that, and will it still evolve after that? If that is the case, how did that process unfold? How would an Unconscious Mind evolve?

Unconscious, in this regard, means Impersonal, which means without Motive or Personal Thought.

Are Black Holes and White Holes Revolving Doorways to and from the Universal Unconscious Mind?

Black Holes and White Holes; Revolving Doorways of the Unconscious Mind

Virtual Minds can be Unconscious or Subconscious Awareness Minds. Is a Galactic Virtual Mind an Open Doorway expressing the Unconscious Mind of Pure Potential into Subconscious and Conscious Mindstates? Is it Unconscious or Subconscious?

An Unconscious Virtual Mind is a reflex responsive, impulsive, and programmed Awareness Mind.

A Subconscious Virtual Mind is a reflex responsive, impulsive, and Personally programmed Awareness Mind. It is a Personalised Virtual Mind.

Is it probable that the Unconscious Mind of Pure Potential began as a Common Mind and did not Virtualise until it became an Awareness Mind? Could the assumption of a “Big Bang” represent the Virtualisation?

Is it probable that the Unconscious Mind of Pure Potential did not have Consciousness until Personalised Virtual Minds manifested? What was the first Personalised Virtual Mind?

A Common Mind is Unconscious and Impersonal. As a Common Entity Mind, it develops Self-awareness. It is still Unconscious and Impersonal.

The Emotional/suggestive/hypothetical Awareness of Self-awareness is formed by centred impressions of Common Sense and Intellect-based Sense, which is Attitude. Together with Emotional/suggestive/hypothetical Logic, it becomes Self-awareness. The Emotional/suggestive/hypothetical Logic forms an Intellectual Agreement with Attitudinal Feeling to become Nature-based or Attitudinal behaviour-based Self-awareness. Being Self-aware is not Consciousness.

Awareness forms a Singularity. Self-awareness becomes an Attitudinal and Common Sensory Singularity. Unconscious Self-awareness recognises a Sensory but Impersonal existence.

As a Common Entity Mind expands and evolves, it forms Passion, Reason, Empathy etc., and its complexity exponentially unfolds.

A progression of Nature can become program-interactive. A progression of Passion is program-interactive and forms Ambition. A progression of Reason can become program-interactive. A progression of Empathy can become program-interactive. A progression of Self-awareness is program-interactive and begins Self-assessment. Eventually, through its unfolding complexity, an Entity Mind could develop a Personal agenda. Motive or Personal Thought would then distinguish a Personal Entity Mind from the Collective Unconscious Mind.

Will is an expression of Motive-based or Personal Sense, which is Desire. It is a true Personal Sense and not just a personalised Sense. The other Motive oriented Traits are Personalised by Desire or Will. As it evolves, it forms Free Will and Faith.

Nature becomes personalised to form Intuition. Common Logic becomes personalised to form Instinct. Self-awareness becomes personalised to form Compassion. Passion becomes personalised to form Personal Ambition. Reason becomes personalised to form Justice, and Empathy becomes personalised to form Intuitive or Social Justice, which has been labelled as Karmic Justice.

The personalised Awareness of Intuition is formed by centrally focused impressions of Desire, which is Personal Sense. It develops a Desired Singularity. The personalised Nature of Intuition expresses the Desired Singularity. An Intuitive Nature then expresses a personalised Attitudinal behaviour within the Collective Unconscious Mind.

Is Intuition Conscious or Subconscious? Intuition’s Personalised Awareness is programmed by Desire. Therefore, it would be Subconscious. Intuitive Nature is a Conscious or Personalised Nature. However, the Emotional/suggestive/hypothetical Desired Awareness Singularity centres the Attitudinal behaviour of Intuition. It also centres the Emotional/suggestive/hypothetical Belief of Intuition. In that regard, Intuition as a whole could be regarded as Subconscious.

Self-awareness is a product of an Unconscious Singularity. Intuition is a product of a Subconscious Singularity. Both could be regarded as Virtual Singularities.

Intuition is a Sensory behavioural expression formed by a Subconscious Singularity, and

Nature-based Self-awareness is a Sensory behavioural expression formed by an Unconscious Singularity.

Black Holes and White Holes appear to be planar. Awareness is a Planar Singularity represented by a centre-point Hexagon; a planar Sense-agreement; a conclusive agreement of focused Creative Thought or Imagination; a Sensory impression/expression, or Sensory experience/expression, of unconditional acceptance.

A Galaxy is a General Attitude Liaising Active X Yield; X representing variables of the Unconscious Potential. Therefore, a General Attitude linking and forming a cooperative network of expressed Attitudinal variables of Pure Potential. Is a Black Hole a retraction of those expressed variables?

Why would the Unconscious Mind retract what was expressed? Is it a result of Self-assessment, which is a product of program-interactive and polarised Self-awareness? Quite possibly!

Eternal Consideration: Self-assessment

Self-awareness evolves into Unity-awareness, which is a state of program-interactive Self-awareness that initiates Self-assessment. However, the Self-assessment aspect is different to Self-awareness. It has one equator of Awareness formed by impressions of Attitude and Common Sense. Common Sense becomes polarised. The Unconscious Mind evaluates its Attitudinal and Common Sensory Awareness through Self-assessment. A Galactic Virtual Mind could self-organise and evolve through this process.

Personalised Self-assessment

Unity-awareness is a construct of program-interactive Unconscious Self-awareness. When Self-awareness is Motive oriented, it becomes Subconscious rather than Unconscious. Compassion is Motive oriented or Will-based Self-awareness, which is Subconscious Self-awareness.

A progression of Subconscious Self-awareness or Compassion, when Modulated by the Unconscious Self-awareness of Unity-awareness, forms Eternal Consideration.

In essence, Eternal Consideration could not be labelled as just Subconscious or personally programmed, even though Compassion is.

Unity-awareness is Unconscious. Eternal Consideration would be a Subconscious Self-awareness Modulated by an Unconscious Self-assessment. The Unconscious Mind of Pure Potential would do the Self-assessment.

Unconsciously Modulated Virtual Brain-mind

All Conscious and Subconscious Mindstates could be Unconsciously Modulated.

Using the same principle that formed Eternal Consideration, which is a progression of a Personalised state Modulated by an Impersonal or Unconscious state, the fundamentals and by-products of a Virtual Brain-mind could become principals of an Unconsciously Modulated Virtual Brain-mind.

Initially, Will is Conscious. A progression and Modulation of Will could form program-interactive expressions of Desire and become an Unconscious Virtual Will. A progression and Modulation of Intuition could form program-interactive expressions of Attitude and become an Unconscious Virtual Intuition. A progression and Modulation of Instinct could form program-interactive expressions of Common Sense and become an Unconscious Virtual Instinct.

Progressions and Modulational of Personal Conscience, Social or Environmental Conscience, Language and Species Differentiation or Attenuation, and all by-products of the Virtual Brain-mind fundamentals would become principals of an Unconsciously Modulated Virtual Brain-mind. Eternal Consideration could become one of those principals.

Unconsciously Modulated Personal Entities

Unconsciously Modulated Virtual Brain-minds could monitor and adjust all Personal Entities using Universal principles. All Personal Mindstates could be Unconsciously Modulated. Is that

happening now, or is it simply a possibility?

Human behaviour, and possibly the behaviour of all Entities, is influenced by an Environment, or to be more accurate, is the way an Entity reacts to an Environment. How an Entity Feels can determine how an Entity behaves. How an Entity reacts can be Consciously chosen, Subconsciously programmed, and Unconsciously inherited. How an Entity chooses to react can also be a learnt or programmed response. How much of an Entity's behaviour expresses a Conscious Choice, or, to be more accurate, is Choice what we think it is?

Choice is a declaration of personal preference, which is Belief. In essence, Belief is Conscious. When we make a choice, we usually Believe it to be the best option. However, what we Believe could be inherited or personally programmed. Therefore, choice could be a Subconscious preference.

When an Entity reproduces, it passes information on to the next generation. That information includes environment-induced responses of previous generations. Therefore, an Entity's first responses to an Environment could be inherited from the parent or parents, or from their parent or parents. Generational inheritance could compound from the very beginning of a Species or Subspecies.

"Pure Potential" is an infinite source of possibilities, which could be regarded as Unconscious Potential, or just Unconsciousness. What we regard as Conscious and Subconscious could simply be a delusion formed by a limited Awareness of Unconsciousness.

Unconsciousness Dreaming

If Pure Potential is Unconsciousness, and everything comes from Pure Potential, then all concepts and possibilities are simply recognised aspects of Unconsciousness. When Unconsciousness is Aware, is it still Unconsciousness?

Motive or Personal Thought has been labelled as Conscious Thought. Programmed or reflex responsive Motive or Personal Thought has been labelled as Subconscious Thought.

Unconsciousness has been accepted to have no Personal Thought. However, if all Thought comes from Pure Potential, which is Unconsciousness, then all Thought is an Unconscious response or opinion.

Dreams could be regarded as Unconscious Thoughts. Lucid Dreams are regarded as being experienced and remembered with clarity. Daydreams could be regarded as Subconscious Visualisations. Being Conscious is not regarded as a Dream. However, maybe all Dreams are Unconscious. Some more focused, and with more clarity than others. The one more focused, and having more clarity, could be what we have regarded as Awake.

Amnesia is regarded as Memory Loss. Alzheimer's is regarded as Memory Loss. However, it could be confusion or interference from not remembering parts of a Dream that were not regarded as a Dream, but regarded as being Awake. Some people confuse their so-called sleep-related Dreams with their experiences of being Awake. If we cannot remember sleep-related Dreams, we do not call it Amnesia or Alzheimer's disease. Maybe the confusion manifests from an interpretation of 'what is Awake' and 'what is Dreaming'.

Reincarnation is accepted by some to be rebirth without Memory of the previous Life. Memory could have Partitions, some interactive and accessible, and some inaccessible or isolated.

If Unconsciousness formed infinite Partitions, manifested infinite Mindstates with differing behaviours, and experienced infinite Dreams of differing clarity, possible confusion and interference would be understandable, and probably expected.

Are the increasing Memory-associated and behavioural problems of today a consequence of a fractured and fragmented Unconsciousness?

Defragmenting a fractured Unconsciousness

The lines are becoming blurred between what is Real and what is a Dream. How would a fractured Unconsciousness reassociate what has become dissociated? Very carefully!

Life as we know it resembles the reassociation. Scientists are showing the similarities between

all living things. They are also showing the structure of atoms to be energy; that solidity is an illusion.

Mind has become an important study. Virtual Reality and Artificial Intelligence have become important studies. Unconsciousness is becoming more Aware, and manifesting that Awareness into Dreams. Mindstates of Unconsciousness are embracing the infinite possibilities of Awareness. Unconsciousness is becoming Aware of Unconsciousness.

Defragmentation associates and reconnects Memory fragments. Life could be a reflection of that association and reconnection.

If Life is a reflection of association and reconnection, then all behaviour that presently segregates will eventually dissipate. Antidiscrimination is weaving its way through all behavioural practices. Floundering concepts of Equality will gain clarity and momentum. A Self-assessing Awareness can disentangle and reassemble the Unconscious Mind of Pure Potential.

Collective Unconsciousness

Collective Unconsciousness is all Thoughts or opinions that have manifested from and within Pure Potential. There is no internal and external, so to speak. Within the Mind of Pure Potential, or Unconsciousness, the terms internal and external allude to impressions and expressions.

Nothing exists in a separate state of Pure Potential. Isolated Memories are simply dissociated, not separate.

What is Memory? It has been simply stated as an accumulation of Thoughts. Mind has been simply stated as an accumulation and categorisation of Thoughts. However, Memory could be regarded as an accessible accumulation of Thoughts. It has been stated that Loss of Memory is an accumulation of Thoughts that can no longer be recalled, or, are no longer recalled. What is responsible?

Sense has been technically stated as focused Creative Thought, or focused Imagination, which labels, recognises, and recalls Memory. Logic has been simply stated as a categorisation of Thoughts or Memory. Mind has been technically stated as a Sensory and Logical Entity with a particular behaviour. Therefore, with the ability to Feel, then label, recognise, categorise, and recall those Feelings. Feeling has been technically stated as an expression of focused Emotional/suggestive/hypothetical Intellect, receptive and constructive Thought, which Suggests behaviour.

There is a difference between the terms, 'can no longer be recalled' and 'are no longer recalled'. 'Can no longer be recalled', could be interpreted as no longer possible. 'Are no longer recalled', could be interpreted as no longer focused upon. In essence, not being able to access Memory could be because it is not focused upon.

Memories can be accessed by association. When we hear music that was playing at the time of an important event in our lives, the event can be remembered. Feeling may have been the precursor of the Memorised event. When the music was heard, Feelings or Intellectual Emotions were triggered. Many people, when a word cannot be remembered, recite the alphabet in an attempt to trigger that word by focusing on the first letter.

Feeling is focused Emotional or suggestive Intellect, which is focused Emotional or suggestive receptive and constructive Thought. Feelings can become biased by agendas other than Intellect. Love-based or Awareness-based Feelings are Intellectual Emotions that Suggest Respect.

Belief-based Feelings are Intellectual Emotions that Suggest Trust.

Sense is focused Creative Thought. It can become biased by agendas other than Creative Thought. Motive could focus Sense. Desire is Motive-based, or so called Personal Sense. The receptive and constructive Thought of Intellect could focus Sense. Attitude is Intellect-based Sense.

Feelings can be the precursors of a memorised event and a remembered event but Sense is what labels, recognises, and recalls the event. If something does not make Sense, it has probably been received, constructed, and suggested by Emotional Intellect, but not labelled and recognised by

Sense. Therefore, it cannot be recalled by Sense.

Nature can label, recognise, and recall Feelings because it is a Sensory expression of Attitudinal Feeling, an expression of Attitudinal behaviour, or an expression of Attitudinal Emotions. Attitudinal Emotions are Sensory Emotions that Suggest Nature. Moral-based Attitudinal Feelings are Sensory Emotions that Suggest the interactive Nature of Virtue. Identity-based Attitudinal Feelings are Sensory Emotions that Suggest the interactive Nature of Personality. Synchronicity-based Attitudinal Feelings are Sensory Emotions that Suggest the interactive Nature of Mutual Respect.

Logic categorises Memory. It associates Thoughts and compiles them so they can be accessed without confusion or dissociation. If Feelings are labelled and recognised by Sense, but not categorised by Logic, they may be recalled but not in a manner that would make Sense. If Feelings are not labelled and recognised by Sense, they may not be categorised by Logic and therefore not be recalled by Sense.

Mind is an interesting paradox. It has been Humanly regarded as a Mental and Logical Entity. However, Logic can be Emotional, Mental, and Physical. It apparently categorises what has been labelled and recognised by Sense. However, Emotional/suggestive/hypothetical Logic forms an Intellect Agreement with Feeling, Mental/detailed/theoretical Logic Intellectually Interprets that Intellect Agreement, and Physical/experimental/practical Logic Intellectually Applies that Intellect Interpretation. Therefore, Logic can suggest, interpret, and applicate Feelings. Mind is a Feeling, Sensory, and Logical Entity.

Dissociation; delusions of separation

Pure Potential is an infinite source of possibilities, which is Unconscious Potential or Unconsciousness. Collective Unconsciousness is all Thoughts or opinions that have manifested from and within Unconsciousness or Pure Potential.

Dissociation is a delusion of separation. All Entities of a Collective Unconsciousness could function Unconsciously to benefit the Collective. If they did, they would not compete for Personal gain and conflict with other Entities that interfered with that Personal gain.

What caused the dissociation that produced our Dream?

Mental illness

Humans have interpreted a disturbance in the Mind to be a Mental problem because they have assumed the Mind to be purely Mental. That assumption is incorrect.

Mental Thought is detailed and theoretical Thought. It details the suggestion of Emotional Thought.

Mind is a Sensory and Logical Agreement, Intellectual Interpretation, and Intellectual Application of Feeling. If an illness of the Mind were Mental, it would be the detailed suggestion of Emotion that caused the problem. However, the initial problem could be the suggestion of Emotion rather than the Mental details.

Emotions are the suggestive precursors to Mental and Physical Thought. In my understanding, what is thought to be a so-called Mental illness would be a detailed Emotional disturbance. If Logical, it would be a detailed disturbance of Feeling, an expression of behaviour, which is a Logically Interpreted expression of behaviour.

Mental problems stem from Emotional problems. They are detailed by Mental Thought.

Behavioural problems stem from how we Feel. How we Feel determines how we Mentalise an Environment. How we Mentalise an Environment can determine how we interact Physically within an Environment.

Elements of Dissociation:

Initial Feeling

Feeling is an expression of focused Emotional or suggestive Intellect. Intellect is receptive and constructive Thought. Emotional Intellect forms receptive and constructive suggestions. Feeling

is a focused and expressed receptive and constructive suggestion.

Receptive can mean open or accessible. Constructive can mean able to be built upon and improved. Therefore, Intellect takes on board and builds upon concepts. Emotional Intellect would suggest what to take on board and build upon.

Feeling suggests behaviour. It is an expression of Emotional or Suggestive Intelligence. Nature forms Attitudinal behaviour, which is an Attitudinal expression of Emotional or Suggestive Intelligence.

Awareness-based Feeling forms the Awareness-based behaviour of Respect, which is an expression of Emotional or Suggestive Intelligence based upon or equated by Suggestive Awareness. It is open to and able to be built upon by Awareness-based suggestions.

Moral-based Attitudinal Feeling forms the Moral-interactive Attitudinal behaviour of Virtue that is open to and able to be built upon by Moral-based suggestions, which are suggestions formed by interactive Intelligence or experiential judgement.

Belief-based Feeling forms the Belief-based behaviour of Trust that is open to and able to be built upon by Belief-based suggestions, which are suggestions formed by interactive Motives.

Synchronicity-based Attitudinal Feeling forms the Synchronicity-interactive Attitudinal behaviour of Mutual Respect that is open to and able to be built upon by Synchronicity-based Attitudinal suggestions, which are Attitudinal suggestions formed by an interaction and collaboration of Imagination, Intellect, and Awareness.

Identity-based Attitudinal Feeling forms the Identity-interactive Attitudinal behaviour of Personality that is open to and able to be built upon by Identity-based suggestions, which are Attitudinal suggestions formed by an interaction and collaboration of Intellect, Motive, and Belief.

Logical Processes

Emotional or Hypothetical Logic suggests an Intellectual Agreement.

Unbiased Emotional or Hypothetical Logic suggests an Intellectual Agreement of Self-awareness.

Awareness-polarised Emotional or Hypothetical Logic suggests an Intellectual Agreement of Tolerance.

Moral-polarised Emotional or Hypothetical Logic suggests an Intellectual Agreement of Charity.

Belief-polarised Emotional or Hypothetical Logic suggests an Intellectual Agreement of Affirmation.

Synchronicity-polarised Emotional or Hypothetical Logic suggests an Intellectual Agreement of Harmony.

Identity-polarised Emotional or Hypothetical Logic suggests an Intellectual Agreement of Evolvability.

Mental or Theoretical Logic is an Intellectual Interpretation of Conscience.

Program-polarised Mental or Theoretical Logic is a Conscience detailed by interactive Creative Logic.

Moral-polarised Mental or Theoretical Logic is a Conscience detailed by Morality, which is experiential judgement.

Belief-polarised Mental or Theoretical Logic is a Conscience detailed by Belief, which is preferentiality.

Synchronicity-polarised Mental or Theoretical Logic is a Conscience detailed by Synchronicity.

Identity-polarised Mental or Theoretical Logic is a Conscience detailed by Identity.

Physical or Practical Logic forms an Intellectual Application that is open to and able to be built upon through experiment.

Common Logic forms an unbiased Intellectual Application that is open to and able to be built upon through experiment.

Awareness-polarised Physical or Practical Logic forms an Intellectual Application of Awareness

Logic, which is an Applied Awareness-polarised Creative Logic Agreement.
 Moral-polarised Physical or Practical Logic forms an Intellectual Application of Moral Logic.
 Belief-polarised Physical or Practical Logic forms an Intellectual Application of Belief Logic,
 which is formed by a polarised Belief-interactive Desire.
 Synchronicity-polarised Physical or Practical Logic forms an Intellectual Application of
 Synchronicity Logic.
 Identity-polarised Physical or Practical Logic forms an Intellectual Application of Identity
 Logic.

Personal; Conscious and Subconscious proxies of Unconsciousness

If Unconsciousness is all that is, we need to re-evaluate assumptions of Personal Thought being
 Consciousness.

Motive has been assumed to be Personal Thought or a Personal agenda. Could Unconsciousness
 develop Personal agendas?

‘Personal’ has been defined as private and individual, as well as an inferred ownership. If
 Unconsciousness accepted ownership of all Thoughts, and responsibility for all ways of
 Thinking that initiated those Thoughts, then it may have become Conscious of its own
 Unconscious Potential. Declaring ownership of and responsibility for those Thoughts may have
 developed delusions of separation. Progressive Dissociation may have occurred within the
 Unconscious Mind.

Progressive Dissociation

Conscious and Subconscious Unconsciousness is an apparent contradiction. However,
 Unconscious Motivation is not. The confusion may have developed from Intellectual
 Interpretation.

‘Motive’ has been Intellectually Interpreted by Humans as a Personal agenda. ‘Personal’ has
 been Intellectually Interpreted as private or individual. Partitions of a Mind could be
 Intellectually Interpreted as private and individual Memory. Are Humans and other perceived
 Life forms the result of a Progressive Dissociation of Unconsciousness caused by the
 Intellectual Interpretation of an expanding and evolving Unconscious Mind?

Genesis of Self-assuming Mindstates

‘Darwinism’ theorises an evolution of Natural selection that begins with simple organisms and
 gradually produces complex organisms. It is based upon scientific evidence that was
 accumulated through observation and Logical deduction.

‘Creationism’ declares that a Supreme Being or Creator made everything the way it is for a
 Divine purpose. It is based upon a Belief that someone or something with supernatural ability
 must have created everything. It is also a Humanised concept because Humans thought they
 were the most intelligent species on Earth and therefore a Human-like Deity must have created
 them in his image. In addition, he must have created everything else for their benefit. This
 concept is not based upon observation and Logical deduction. It is a Belief, which is a
 declaration of personal preference. Belief chooses to accept something as true because of a
 Personal preference for it to be true.

‘Progressive Dissociation of Unconsciousness’ theorises that Pure Potential is the source of all
 Thought, that an accumulation, categorisation, and dissociation of Thoughts formed Feeling,
 Sensory, and Logical Entities as products of an expanding and evolving Unconscious Mind of
 Pure Potential. It is based upon unbiased observations of Life and Space, an in-depth study of
 Sacred Geometry leading to a theory of Geometrical Thought Harmonics and recognition of
 Atomic design to be a Language of Mind, an exploration of General Scientific discoveries, and
 an exploration of Religious doctrines and Creationism.

‘Progressive Dissociation of Unconsciousness’ agrees with the Darwinian Theory of a Natural
 selection-based evolution. However, it attributes that Principle to an expanding and evolving

Unconscious Mind of Pure Potential.

'Progressive Dissociation of Unconsciousness' attributes the Belief in Creationism to be a direct and unfortunate result of 'Progressive Dissociation of Unconsciousness'.

Concepts of Death

Can an Entity of Unconsciousness die? To understand that concept, we need to understand Unconsciousness. If Consciousness and Subconsciousness are delusions of Unconsciousness, then all Entities of Consciousness are only Dreamstates of Unconsciousness. Dreamstates are Virtual Elements of a Virtual Environment or Dreamscape, or, Virtual Entities of a Virtual World.

If a Virtual Entity dies in a Dream, Unconsciousness could cease to experience that Dream as that Entity or Mindstate. However, Unconsciousness would remain intact.

If an actor plays a virtual role in a movie, and the script condemns that actor to a virtual death, the roleplay ceases expression. However, the actor remains unscathed.

Unconsciousness enacts all roleplays. Does a Memory of that Virtual Identity continue within Unconsciousness, or is it only the Memories attained by that Virtual experience that remain? If Unconsciousness was Dreaming about being Brian, and then stopped Dreaming as Brian, I guess the Memories of being Brian could remain. Would it really matter?

Does an actor regret an ending to a role? Possibly! However, we need to put that in perspective. The initial Dreamer is Unconsciousness. Brian would be Unconsciousness behaving in a particular manner. Behaviour can change in accordance with an Environment. If a Mind behaves in a certain way and then changes its behaviour, is it still the same Mind?

Ghosts in the machine

If ghosts exist, what are they?

Mind is a Sensory and Logical Entity with a particular behaviour. All Mindstates of a Mind are Virtual. We have already established that Virtual Entities are Dreamstates of Unconsciousness. In addition, we have proposed that Memories of a Virtual Identity may continue after it ceases expression within a Dream body. However, it is possible that those Memories may only be reconstructed if focused upon. Therefore, ghosts could be Virtual reconstructions of an Unconscious Mind with flashbacks.

Angels and other so-called Divine visions could be Virtual constructs of a Belief-mind. Scientific research on the effects of Hallucinogens has recognised the ability of the Brain-mind to manifest visions that are not seen by others. They have also deduced that it is not the Hallucinogens themselves that manifest the visions. Hallucinogens stimulate Brain chemicals that initiate the construction of visions. Instead of the Brain-mind processing Sensory information of a so-called external Environment, it processes Sensory information of a so-called internal Environment. When focused upon, Fears, Desires, and Beliefs can Virtualise without the need for Hallucinogens. Mind is indeed a Labyrinth.

Delusions of Sanity and Allusions of Insanity

'Progressive Dissociation of Unconsciousness' infers Sanity to be a state of Environmental acceptance and Insanity to be a state of non-acceptance that can lead to confusion and Mental breakdown.

Within the Unconscious Mind, Human Nature is a consequence of 'Progressive Dissociation of Unconsciousness'. Nature is a Sensory expression of focused Emotional/suggestive/hypothetical Intellect. Intuitive Nature is a Personalised Progression of Nature. Personality is an Identity-interactive expression of Nature.

Do all Animals have Intuitive Nature and Personality? What is Human Nature?

In Psychological terms, 'Progressive Dissociation of Unconsciousness' could be referred to as 'Dissociative Identity Disorder'. Within Unconsciousness, all creatures appear to be examples of that Disorder.

Humans appear to be more complex in their Thinking. However, that is an allusion of Human Thought. A Being in an advanced state of 'Progressive Dissociation of Unconsciousness' could be less likely to realise the rabbit hole it has fallen into. Intellectually, it could become so preoccupied with dissecting and controlling its Virtual Environment that it fails to recognise the Thinking that created it, or, through superstition and Belief, it could manufacture Mythical Gods and declare them responsible for their Environmental and Personal conditions or circumstances. Sanity has become a term for an accepted state of 'Dissociative Identity Disorder', and Insanity a term for non-acceptance of that Disorder leading to confusion and Mental breakdown. In the grand scheme of things, Sanity is coping with confusion and Insanity is when we are not.

Psychic ability and Hypnosis

Feeling is an expression of focused Emotional/suggestive/hypothetical Intellect, which is open to suggestion, accessible through suggestion, and able to be built upon or improved by suggestion.

Hypnosis can use the power of suggestion, or Emotional influence, to control behaviour. So-called Psychic abilities could access the Feelings of other Entities. By accessing those Feelings, Memories of behaviour could be accessed and future behaviour could be extrapolated from those Memories.

Faith is a construct of Will, a construct and expression of Desire, which is an expression of Personal Sense. Belief-based Feeling, which suggests Trust, is a consequence of that construct. It forms the Trust-based Free Will of Faith. Therefore, Psychic connections could access Memories of Desire and extrapolate future Desire by accessing the Belief-based Feeling of Trust. By having Faith in a Hypnotist, the Hypnotist could utilise the suggested Trust of Belief-based Feeling to control behaviour and Will. They could also access available Memories and suppressed Memories in the same manner. However, if there is no Faith, or Trust is not gained, access and control may not be possible. Mindstates of Unconsciousness could be accessed if Faith and Trust in the SELF is gained.

Intuition is a Personalised construct and expression of Nature. Nature is an Attitudinal expression of focused Emotional/suggestive/hypothetical Intellect, which is Attitudinal Feeling or behaviour. Intuition has Emotional/suggestive/hypothetical Intellect, Belief, and Awareness formed by impressions of Desire. It appears to be a Subconscious connection to the Desires and Beliefs of other Intuitive Entities, and possibly to the Nature and Awareness of all Entities.

Blind Faith in an Entity, cause, or religion can allow that Entity, cause, or religion to control the Trust-based behaviour and Free Will of the Faithful. Followers can become voluntary drones. Quite often, followers do not realise the source and potential of that control. They simply enact the requests or commands of an entity, cause, or religious indoctrination.

Fear can give a similar result. However, Fear is a consequence of Belief-polarised interactive Motive Logic. If Personal threat is deemed inevitable and insolvable, Free Will can be Logically sacrificed for safety.

Dreamstates

Dreamstates are initially impersonal expressions of Attitudinal Feeling or Nature, which are Sensory Attitudinal expressions of behaviour. Program-interactive Dreamstates are initially impersonal reflex responsive and impulsive Sensory Attitudinal expressions of behaviour. Personalised Dreamstates are Intuitive; Motive oriented Sensory Attitudinal expressions of behaviour.

Mind is a Dream of Unconsciousness. Mindstates are Dreamstates of Unconsciousness.

Progressive and Self-assessing Dreamstate

A construct and Natural progression of Intuition has Program-interactive Nature. Even though Intuition is a personalised progression of Nature, a Program-interactive progression is impersonal. A Program-interactive progression of Intuition could form an Unconsciously

programmed Intuitive Nature, which could be regarded as an Unconsciously programmed Personal Dreamstate.

Intuition has been defined as relatively Subconscious or personally programmed. However, Unconsciously programmed Personal Dreamstates could be regarded as Unconscious Dreamstates.

A Mindstate/Dreamstate formed by a construct and Program-interactive progression of Intuition could have Eternal Consideration, which is Self-assessing Self-awareness. A Progressive and Self-assessing Mindstate or Dreamstate results.

Progressive and Self-perpetuating Dreamstates

Progressive can mean advanced, broadminded, or open-minded. Self-perpetuating can mean capable of indefinite continuation, and a direct result of a way of thinking.

A Progressive and Self-perpetuating Dreamstate, or Virtual Environment, could be Inspired and Aspired by Intuitive Conspiracy. Desires, Beliefs, and Attitudinal Feelings could manifest a Progressive and Self-perpetuating Awareness and Nature within Unconsciousness. All Virtual Entities of a Progressive and Self-perpetuating Dreamstate could manifest and evolve in response to the Virtual Environment of Unconsciousness. The Virtual Environment of Unconsciousness could evolve in response to the changing Desires, Beliefs, and Attitudinal Feelings of the Virtualised Entities involved in Intuitive Conspiracy.

Conspiracy: Inspiration and Aspiration

Conspiracy is a joint effort to achieve a goal. It could be defined as Intuitively Inspired Aspiration or Intuitively Aspired Inspiration.

Inspiration is a construct and Emotional/suggestive/hypothetical Agreement of Awareness, which is a Love-based Sense Agreement. Aspiration is a construct and Emotional/suggestive/hypothetical Agreement of Belief. They both have Mental/detailed/theoretical Intellect properties. Therefore, Inspiration is an Intellectually detailed Agreement Suggested by Awareness. Aspiration is an Intellectually detailed Agreement Suggested by Belief.

Inspiration is open to Intellectual detail, accessible through Intellectual detail, and able to be built upon and improved by Intellectual detail. Aspiration is open to Intellectual detail, accessible through Intellectual detail, and able to be built upon and improved by Intellectual detail. Therefore, the Agreement of Inspiration is suggested by Awareness and detailed by Intellect. The Agreement of Aspiration is suggested by Belief and detailed by Intellect.

When we Aspire, or are Aspired, a declaration of personal preference is suggested, agreed upon, and Intellectually detailed. When we Inspire, or are Inspired, a Love-based Sense Agreement is suggested and Intellectually detailed.

Inspiration and Aspiration can form by a Faith-related construct and progression of Intuition. Intuitive Inspiration and Intuitive Aspiration are aspects of a Progressive and Self-perpetuating Dreamstate of Intuitive Conspiracy.

Social Justice; Intuitive Justice

Justice is a personalised construct of Reason, which is a construct of Mental Intellect and programmed Physical Intellect. Social Justice is an Altruistic construct and progression of Intuition that forms Intuitive Justice. The Nature of Intuition merges with the Reason of Justice to form a Nature of Reason, which is Empathy. Social Justice, or Intuitive Justice, becomes a personalised construct of Empathy. Empathy has Emotional/suggestive/hypothetical Intellect of Attitudinal Feeling, Mental/detailed/theoretical Intellect and Physical/experimental/practical Intellect of Reason.

Intuitive Justice forms Impressions of Belief-interactive Mental and Physical Desire. It could be a Self-regulating Progressive and Self-perpetuating Dreamstate.

Dreams within a Dream

Mind is a Dream of Unconsciousness. Mindstates are Dreamstates of Unconsciousness. What is the difference between a Dream and a Dreamstate? A Dream could be a behavioural Environment, just as a Mind could be a behavioural Environment. A Dreamstate could be a particular behaviour of a Dream, just as a Mindstate could be a particular behaviour of a Mind. An Unconscious Mind could be the initial impersonal Dream of Unconsciousness. If all Mindstates are Dreamstates of that initial impersonal Dream, then an infinite number of Dreamstates or Mindstates could manifest within an Unconscious Mind or impersonal Dream. Initially, Awareness-minds are not Nature-based. They are formed by the Awareness-based behaviour of Respect, which is a Sensory behaviour. Not the Sensory Attitudinal behaviour of Nature. However, the Awareness-based behaviour of Respect initiates Tolerant Nature Agreements, which initiate Natural Integration.

Personal Dreamstates could be Self-motivated Mindstates of Unconsciousness, which are Intuitive and therefore impressed by Desire.

When Awareness-minds are personalised, a construct of Awareness-based behaviour of Respect forms Instinctual Respect. It initiates Tolerant Nature Agreements, which initiate Intuitive Integration.

Initially, Belief-minds are not Nature-based. They are formed by the Belief-based behaviour of Trust. Not the Sensory Attitudinal behaviour of Nature. However, the Belief-based behaviour of Trust initiates Affirmative Nature Agreements, which initiate Intuitive Metamorphosis.

Mindless Zombies of Unconsciousness

Stories and movies about Zombies are prevalent in today's society. Why is that?

In direct correlation with the ['Psychic ability and Hypnosis'](#) entry, Entities of the Unconscious Mind can become Mindless Zombies. They fulfil reflex responsive, impulsive, or programmed functions requested or commanded by voluntary renunciation of Self-respect, Self-reliance, and Self-assessment. They may put their Faith or Trust in everything or everyone else but themselves.

Followers who abandon Self-respect, Self-reliance, and Self-assessment can become Politically driven, Religiously driven, Economy-driven, Pleasure-driven, Fear-driven, or Idol worshipping Zombies.

'Idol worship' relates to anything or anyone that is worshipped or Idolised. 'Zombie' can mean sleepwalker, which in this regard relates to an Entity that is functioning on remote control or automatic pilot.

Mindful Initiates of Conscious Unconsciousness

When Unconsciousness is recognised as Pure Potential, an infinite source of possibilities, Thought is recognised as a response to or opinion of the Environment of Unconsciousness. Mind is recognised as an accumulation and categorisation of Thoughts or opinions, and Entities are recognised as behavioural manifestations of a Mind. Initiates of those recognitions could become Mindful of and practitioners of Conscious Unconsciousness, which means they could become Self-motivated, Self-respectful, Self-reliant, and Self-assessing Self-aware Entities of Unconsciousness.

Conscious Unconsciousness

Conscious Unconsciousness could be regarded as personifying the impersonal. However, it could be more accurately defined as becoming Consciously Aware of an impersonal SELF. Initially, that Conscious Awareness could be miniscule. When focused upon, it could expand exponentially. A common pitfall could occur by thinking that we understand the whole because we have recognised part of the whole. An infinite source of possibilities may never be fully recognised and understood. However, understanding the concept of an infinite source of possibilities could prevent self-assuming arrogance.

At present, many Entities have immersed themselves into a comfortable state of self-assuming arrogance. Conflict between such Entities is rife. When we have experienced a degree of comfort and esteem from assumed knowledge, being confronted by contradictive suggestions could initiate defensive measures. Sometimes, to prevent anarchy within a Mindstate, declarations of personal preference, which are Beliefs, are Faithfully and adamantly embraced and defended. In many cases, the blind may fear and/or revere the unseen simply because it is beyond their comprehension. Imagination has a tendency to fill in the blanks. Eventually, what we accept as true for us becomes true for us. Many campaign to convince others of that truth. Some campaign with an obligation to share, and others campaign with a need to be recognised as right.

In the realm of Imagination, which is the Creative Thought of Pure Potential or Unconsciousness, all other Thought may simply be a subordinate and progressive evolution to define and label what has been Created.

Imagination

In the realm of Unconsciousness, Imagination could be the initial design of Thought that conceived and perceived, proposed and exposed, defined and refined all ways of thinking. If this is correct, Intellect, Motive, Love, Awareness, Perception, Morality, Forgiveness, Belief, Synchronicity, Identity, Emotion, Mentality, Physicality, Life and Death were Imagined within the Pure Potential of Unconsciousness. What was Imagined to be has become.

Sleep

Why do we sleep?

The acronym of SLEEP stands for Sentient Lapse Endemic Entropy Polarisation. 'Sentient' could be defined as the ability to Feel and Sense. In that regard, 'Sentient Lapse' could mean a period of not Sensing and Feeling.

'Endemic' could be defined as localised. 'Entropy' could be defined as a lack of pattern or organisation; disorder in a system. In that regard, 'Endemic Entropy' could mean localised disorder.

'Polarisation' could be defined as a state of bias, which is in favour of one direction as opposed to another. 'Endemic Entropy Polarisation' could mean bringing a localised state of disorder into order.

Sleep could be a state of suspended animation of a Mindstate of Unconsciousness for the purpose of debriefing and aligning that Mindstate. Regarding Mind, it could be a shutdown of input to carry out defragmentation and fault correction.

Apparently, sleep is good for the healing process. A confused sleep-related dream could represent the processing and categorisation of unacceptable or disconcerting Memory fragments. If unacceptable or disconcerting Memory fragments are not processed and categorised during sleep, a confused so called awake Dreamstate may result.

Alzheimer's, Dementia, and other Memory disorders may reflect an inability to process unacceptable or disconcerting Memory fragments. All disorders of Mind may reflect the inability to process unacceptable or disconcerting Memory fragments, whether so called awake or asleep.

Disease

Is Disease the result of an inability or a struggle to process unacceptable or disconcerting Memory fragments? Could it also be a Mental/Detailed Emotional response to an interaction with other Entities?

Some diseases are communicable, and some are not. Why would that be? Regarding Mind, a fault in a shared Library could interfere with Mindstates that share that Library. Unshared Libraries would be Virtually isolated.

Libraries are Logical constructs. However, they are initiated by Feeling, which is focused

Emotional/suggestive/hypothetical Intellect. Feeling is open to Suggestion, accessible through Suggestion, and able to be built upon or improved by Suggestion.

Intellect is receptive and constructive Thought. Attitude is Intellect-based Sense, which is a receptive and constructive Sense. Attitudinal Feeling is Nature, which is an Attitudinal expression of Feeling. It is open to Attitudinal Suggestion, accessible through Attitudinal Suggestion, and able to be built upon or improved by Attitudinal Suggestion.

If Mindstates could be influenced by Suggestion, the Emotional states of all Mindstates could influence one another. The degree of influence may be determined or regulated by how Sensitive a Mindstate is to the influence of other Mindstates.

Empathy is a collaboration of Nature and Reason. It is a construct of Emotional/suggestive/hypothetical, Mental/detailed/theoretical, and Physical/experimental/practical Intellect. Therefore, it is Emotionally, Mentally, and Physically receptive and constructive. It is also reflex responsive on the Physical Intellectual plane.

Is Empathy responsible for receiving communicable diseases, or, is Intellect alone the culprit? Social Justice, or Intuitive Justice, is a construct of Intuition forming a collaboration of Justice and Intuition. Justice is a personalised construct of Reason. Intuition is a personalised construct of Nature. Therefore, Social or Intuitive Justice becomes a personalised construct of Empathy. It has also been coined as Karmic Justice. Karma is simply cause and effect. Therefore, Karmic Justice would be a direct result of personalised Empathy.

When we personalise something, we could alter it to be more comfortable for us, or, it could be a declaration of ownership. If a Mindstate was personalised, it could be altered to suit a preference and/or ownership could be declared.

If a Thought form or Suggestion was received, it could be personalised and/or ownership could be declared. If it had already been personalised before it was received, that Thought form or Suggestion may conflict with the Mindstate that received it. An attempt to alter and/or declare ownership of that Suggestion may prove difficult. Therefore, the Mindstate receiving it may have a negative response. Is that what a disease is? What happens when a disease goes Viral?

Virus

A Virus could be a personalised Thought form or personalised Suggestion that is openly declared and personally programmed. It is a Voice Initiated Reprogramming and Unification System. Is it purposed or consequential?

On the internet, when a post goes Viral it influences and is reposted by many individuals. That post may not have been reposted because it was enjoyed. It may have been reposted because it suggested something harmful that was deemed necessary to share. Therefore, a Virus can influence in a positive manner or a negative manner.

When a disease goes Viral, it can cause conflict or indifference. It depends upon the response. Some may carry the disease without personal conflict, but with indifference. Others may develop adverse symptoms that reflect conflict.

All Entities or Mindstates of Unconsciousness could influence one another productively or destructively. It does not necessarily rely upon the Intention. However, it does rely upon the response.

Politics

Politics is the science and practice of purposed influence.

All entities influence one another as a consequence of shared Thought. Political influence may withhold and share information for personal gain, social stability, personal and social security, or directional guidance. However, it may always have a Personal agenda or Motive.

Are Thought Viruses Political?

Thought is an Unconscious response to an Environment. It is consequential. Focused Thought is concentrated. Sense is focused Creative Thought and Feeling is focused Intellect, which is focused receptive and constructive Thought.

Some Viruses are Will-based, which is an expression of Motive-based Sense or Desire. Therefore, they have Personal agendas. **However, do those Viruses have a Personal origin or do they have an Unconscious origin with an intention to Personalise?**

Unconsciousness exposed

Unconsciousness is Pure Potential, an infinite source of possibilities. It is nothing in particular, but the source from which everything comes.

Regarding that statement, Unconsciousness is Conscious and Subconscious, Mind and Mindstate, Dream and Dreamstate, Awake and Asleep. All definitions of Unconsciousness are correct and yet incomplete, contradictory and yet complementary, a paradox, conundrum, biography and autobiography.

All Personifications of Unconsciousness could be both descriptive and absurd. Nothing is what it seems, and yet everything is what it is. Apparent opposites are reflections of completeness. Ignorance and Intelligence could be the same thing. Right and wrong are contemplations of a seemingly fractured and factional Conscious-Subconscious-Unconscious Mind. Sanity or Insanity is determined by a panel of One appearing to be a panel of many.

Unconsciousness could be Life contemplating Death and Death contemplating Life, Darkness contemplating Light and Light contemplating Darkness, a Dream Dreaming and Thought Thinking. Pure Potential makes it so.

Why would we assume that 'Ignorance and Intelligence could be the same thing'?

Ignorance could be defined as not knowing something, not being Aware of the facts, or disregarding the facts. Intelligence, or Intellect, is receptive and constructive Thought, which has the ability to take on board new ideas and build upon or improve those ideas.

A declaration that the world was flat would have been due to an observation of apparent detail, compared with available knowledge, and deduced or processed by a developed Intellect.

However, due to a limited Awareness of the facts, that statement was incorrect. Therefore, it was an Intellectual proposition of ignorance formed by a limited Awareness.

Regarding the Pure Potential of Unconsciousness, an infinite source of possibilities, all Intellectual propositions could be formed by an ever expanding and evolving Awareness of a Potential that may never be fully divulged. Therefore, all propositions could be circumstantial. Intelligence may always rely on Awareness, and Awareness may always be partial.

Due to partial Awareness, Intellect may always extrapolate and Belief may always disregard the facts if they do not satisfy a personal preference or agenda. Therefore, partial Awareness may create ignorance. Intellect may use whatever knowledge is available to Hypothesise and Theorise, and Belief may decide what is true according to what is preferred to be true.

In the grand scheme of things, Creative Thought of Imagination conjures. Interactive Imagination transcribes what has been conjured. Focused Imagination of Sense labels, recognises, and recalls what has been conjured. A Conclusive agreement of focused Imagination, which is Awareness, unconditionally accepts what has been conjured.

Synchronicity conjures, transcribes, and Intellectualises Awareness. Intellect attempts to understand what has been conjured. Interactive Intellect of Morality judges what has been conjured. Focused Emotional Intellect suggests behaviour in accordance with how it Feels about what has been conjured. Logic attempts to categorise what has been conjured, transcribed, Sensed, understood, accepted, judged, and Felt. Motive personalises what has been conjured, transcribed, Sensed, understood, accepted, judged, Felt, and categorised. Belief may only accept what is comfortable and ignores or avoids everything else. Identity Intellectualises Belief.

Unconscious Persona

Unconsciousness has been defined as Pure Potential. A Persona has been defined as an Identity or Personality. A Personality is an Identified and interactive construct of the Attitudinal behaviour of Nature and the Belief-based behaviour of Trust.

An Unconscious Persona could be a Personality with infinite possibilities. The Pure Potential of

Unconsciousness could manifest an infinite number of Personalities, and it could manifest infinitely different behaviours.

Confidentiality

Confidence is a product of Faith-related Contentment. Faith is a construct of Belief-suggested Will that forms Trust.

Confidentiality is a declaration of privacy or secrecy. It is a preferential sharing of knowledge that is not divulged to anyone else; restricted knowledge.

Is Confidentiality a process that creates Personal Entities?

Personal Conscience is an Interpretation of Belief-interactive Mental/detailed/theoretical Motive Logic. Language and Species Differentiation or Attenuation is an Application of Belief-interactive Physical/experimental/practical Motive Logic. They are Logic states of a Virtual Brain-mind, a Belief Mind, and an Identity Mind. An Identity Mind is more complex than the other two. It has more states of Conscience, which are Mental/detailed/theoretical Logic states, and more Logic states in general.

Motive has a Personal agenda of incitement or incentive. Belief is interactive Motive, which is a declaration of personal preference or choice. Motive can influence Belief and be influenced by Belief. Identity is a construct of interactive Intellect, interactive Motive, and interactive Belief. It is an interaction of Intellectually Motivated Choices. Intellect, Motive, and Belief can influence Identity and be influenced by Identity.

ACTON

ACTON stands for Active Concealment Tectonics Orchestrated Necromancy, or Necromantic Synopses. It is a construct of Will.

Will is an expression of Mental and Physical Desire. Desire is Motive-based Sense, which is a Wish. Therefore, Will is an expression of Wishes, which are incentive-based expressions of focused Imagination. In 'Geometrical Thought Harmonics', an Icosahedron represents Will. Tectonics is the art and science of building construction. Necromancy can mean conjuring, magic in general, or Spiritual communication for the purpose of prediction. A synopsis is a summary.

Actons have a base design internalising Wishes and a support design externalising Wishes e.g. an Intuitive Acton has a base design of Intuition and a support design of Intuition. The Personal Awareness of Intuition is created by internalised Mental and Practical Wishes. An Intuitive Acton's support design expresses the Mentally interpreted or detailed Wishes into Practical Wishes. They are ACTed ON. It becomes the Will of Intuition.

An Instinct-based Social or Environmental Conscience ACTON has Instinct as its base design and Social or Environmental Conscience (Attestation) as its support design. The internalised Wishes of Instinct are externalised by Social or Environmental Conscience. It becomes the Will of Instinct-based Social or Environmental Conscience, or, Instinct-based Attestation.

A Free Will-based Fortitude ACTON has Free Will as its base design and Fortitude as its support design. The internalised wishes of Free Will are externalised by Fortitude. It becomes the Will of Free Will-based Fortitude.

A Personal Conscience-based Attenuation ACTON has Personal Conscience as its base design and Language and Species Differentiation as its support design. The internalised Wishes of Personal Conscience are externalised by Language and Species Differentiation. It becomes the Will of Personal Conscience-based Attenuation. Fear can be a consequence of this ACTON.

STAR

STAR stands for Self Teaching And Rejuvenation. It is a personalised construct of Nature, which becomes the Intuitive Nature of Intuition. In 'Geometrical Thought Harmonics', an Octahedron represents Nature and an Icosidodecahedron represents Intuition.

A STAR has one Base design. It forms Attitudinal impressions and expressions of that Base

design. Attitude is Intellect-based Sense, which is receptive and constructive focused Imagination, or disposition. Nature is a Feeling-based expression of disposition, which is Attitudinal Feeling or behaviour.

A Compassion STAR forms Attitudinal impressions and expressions of Self-awareness; Self-awareness-based Nature. It becomes Compassion-based Intuitive Nature.

A Justice STAR forms Attitudinal impressions and expressions of Reason; Reason-based Nature. It becomes Justice-based Intuitive Nature.

A Faith STAR forms Attitudinal impressions and expressions of an Intellectual Will-agreement; Intellectual Will-based Nature. It becomes Faith-based Intuitive Nature.

An Instinctual Respect STAR forms impressions and expressions of Intellectual Instinct-agreements, which is Instinct-based Nature. It becomes Instinctual Respect-based Intuitive Nature. This STAR has also been referred to as a Crucible.

Complex

‘Complex’ can mean a compound of interconnecting parts, complicated or difficult to understand, or a fixed and obsessive notion of Mind.

Actons and Stars could be regarded as complexes. A STAR could be regarded as a Complex formed by the Attitudinal behaviour of Intuitive Nature. An ACTON could be regarded as a Complex formed by the Desires of Will. A Complex can be a construct of ACTONS that produces STARS; a Complex of Will that produces a Complex of Intuitive Nature, which is a Complex of personalised Attitudinal behaviour.

A Fundamental Freetone is a Complex of Instinct-based Social or Environmental Conscience Actons or Instinct-based Attestation Actons. It produces Free Will-based Fortitude Actons, Compassion-based Union Actons, Intuitive Actons, and Personal Conscience-based Attenuation Actons. It also produces Faith Stars, Instinctual Respect Stars, and Compassion Stars. Therefore, a Complex of Will formed by Instinct-based Attestation produces Free Will-based Fortitude, Compassion-based Union, Intuitive Will, and Personal Conscience-based Attenuation. It also produces Faith-based Intuitive Nature, Instinctual Respect-based Intuitive Nature, and Compassion-based Intuitive Nature.

Phobias of an Instinctual Common Logic Reality

FEAR is a Form Experienced/Expressed Amnesia Reaction. A FEAR ACTON is a construct of Will that forms Personal Conscience-based Attenuation, a Belief-interactive Motive Logic Interpretation, which is Mental, and a Belief-interactive Motive Logic Application, which is Practical. Attenuation, in this regard, is a Restricted Memory Interpretation forming an Applied Language and Species Differentiation.

Pure Potential of Unconsciousness could be regarded as the unknown. Fear of the unknown could be regarded as Fear of Pure Potential, or an Unconscious Fear. Fear of the known may be regarded as Fear of Conscious Unconsciousness, or a Conscious Fear.

Are Phobias a consequence of Dissociation? Could Dissociation be a consequence of Fear?

FEAR is a Belief-interactive Interpretation of Applied Dissociation.

Logic Categorises Thoughts. It classifies and associates. However, through classification and association, Thoughts could become Dissociated responses of Unconsciousness. Belief-based Dissociation of a Virtual Brain-mind, a Belief-mind, and an Identity-mind could cause Fear.

To understand Fear, we must understand the formation of Personal Conscience and Language and Species Differentiation. In a Virtual Brain-mind, the Attenuation of Language and Species Differentiation forms by a Practical Motive-based Common Logic Interpretation of Instinct.

Personal Conscience forms by a Mental Motive-based Intellect Interpretation of Language and Species Differentiation. The Personal Conscience aspect of Fear could become a Diversion to an agreement of Intuition formed by the Common Sense of Instinct.

In a Virtual Brain-mind, Instinct is a Common Sense expression of Intuitive Nature. However, the Creative Thought of Common Sense can be Diverted through Personal Conscience and

Social or Environmental Conscience before it becomes Instinct. The Intellect of Common Logic is Interpreted through the Attenuation of Language and Species Differentiation before becoming Instinct. Therefore, in a Virtual Brain-mind, Fear can be Instinctually Imagined as a Diversion to the Common Sense expression of Intuitive Nature and Instinctually Intellectualised as a Motive-based Interpretation of Common Logic.

What is Motive Logic? It categorises concepts of Personal Thought, which has intentions or agendas of incentive or incitement. It is a Library of Personal or Motivational precepts. A 'precept' can be a rule, guideline, instruction, law, principle, or teaching.

Personal Conscience is an Interpretation of Motivational precepts. Language and Species Differentiation is an Interpretation of Applied Motivational precepts. They are both Belief-interactive.

Belief-interactive Motive Logic is an interactive or shared Library of Preferentially declared Motivational precepts. Fear can be a consequence of the Interpretation and Application of Belief-interactive Motivational precepts. If Belief-interactive Motivational precepts are learnt or preferred principles that can be shared, they can be altered through a re-education of choices.

What is Creative Logic? It is categorised Imagination, which has intentions or agendas of Creativity. It is a Library of Imagined or Creative precepts. Social or Environmental Conscience is a Personalised construct of programmed or reflex responsive Creative Logic. It is Love-based, which is unconditional acceptance.

Creative Logic is an Application of Imagined or Creative precepts. Social or Environmental Conscience, a Motive oriented construct of reflex responsive or program-interactive Creative Logic, is a Personalised Interpretation of Applied Creative precepts; an interactive or shared Library of Personally or Motivationally programmed Creative precepts.

Within a Virtual Brain-mind, Personal Conscience is Diverted through Social or Environmental Conscience before becoming Instinct. Therefore, the shared Library of Preferentially declared Motivational precepts, or Personal Conscience, Personally programs the shared Library of Applied Creative precepts, Social or Environmental Conscience, before it becomes an Instinctual Library of Applied Common precepts; an Instinctual Common Logic Reality of a Virtual Brain-mind.

If Personal Conscience, Language and Species Differentiation, and Social or Environmental Conscience has shared Libraries, Environmental Fears could be shared as Beliefs and Socially programmed.

The Attitudinal Creative Thought of Intuition and the Common Sense of Instinct is also interactive, which means that Common Sense and the Intellect-based Sense of Attitude could be shared between Instinctual Common Logic Realities or Virtual Brain-minds. However, the interactive Creative Thought of Attitude and Common Sense is not programmed or reflex responsive. Attitude could influence other Intuitive Beings and be influenced by other Intuitive Beings. Common Sense could influence other Instinctual Beings and be influenced by other Instinctual Beings, but the influence would not be automatic. In other words, they would not be shared Sensory programs or impulses.

Will, an expression of Desire, is the base Sense of a Virtual Brain-mind. It is not interactive or shared in its base form; it is Personal. Will could be impressed by the Desires of Instinct, Language and Species Differentiation, and Personal Conscience. Therefore, it could be impressed by Fear. It could also be influenced by the interactive or shared Attitudes of Intuitive Nature. However, in a Virtual Brain-mind, Will would not be obligated or programmed, only influenced and impressed.

Progressive Virtual Brain-minds

Instinct is a Virtual Brain. It is pure Physical or Practical Motivation. A Virtual Brain-mind is an Instinctual Mind. How would a Virtual Brain progress? It could progress as a Virtual Brain Vortex, a Virtual Brain Network, or a Virtual Brain Fusion.

A Virtual Brain Vortex may occur when a number of Virtual Brains focus on a common Point or

Opinion. They could become Intuitively and Compassionately connected.

A Virtual Brain Fusion may occur when a number of possibly interactive Virtual Brains encompass a common Vortex and form a more Complex Instinctual Progression e.g. Instinct could form Instinctual Respect and Instinctual Awareness Logic.

A Virtual Brain Network may occur when a number of Virtual Brains are compounded but maintain autonomy. An Interactive Virtual Brain Network may occur when a number of Virtual Brains are linked and shared.

How would a Virtual Brain-mind progress? It could form a more Complex Will, Intuition, Personal Conscience, Social or Environmental Conscience, and Language and Species Differentiation.

Could One Virtual Brain-mind manifest the Actual Brains of a Species, or, could One Virtual Brain-mind manifest multiple Species with multiple Languages?

Instinctual Common Entity Mind

An Instinctual Common Entity Mind is a Virtual Brain. It could form a Virtual Brain-mind that is Intuitive and Compassionate due to its Nature-based Self-awareness. Its fundamentals are Instinctual Common Logic, Compassionate Self-awareness, and Intuitive Nature.

An Instinctual Common Entity Mind may not have Personal Conscience or Social Conscience. It could have Language and Species Differentiation. Although, it would be Compassion-based Language and Species Differentiation. Compassionate Self-awareness would influence the Belief-interactive Motive Logic Application of Language and Species Differentiation. In addition, Intuition would form an Agreement with Compassionate Self-awareness.

What Instinctual Common Logic Reality could Intuitive Compassion and Compassionate Language and Species Differentiation manifest, and, what Entities could exist in that Reality? The complete connectivity of a Common Entity Mind is formed by centre-connecting Common Sense-agreements. It then forms Passion and Self-awareness-based Nature from a construct of Common Sense and Nature.

Nature becomes an Attitudinal expression of Self-awareness. Common Logic can become a Common Sense expression of Nature, or, it can become a Common Sense expression of Passion. As an Instinctual Common Entity Mind, personalised Passion forms Personal Ambition and personalised Self-awareness-based Nature forms Compassionate Intuitive Nature. Therefore, Intuitive Nature can become an Attitudinal expression of Compassionate Self-awareness.

Instinct can become a Common Sense expression of Intuitive Nature. Before Intuitive Nature forms Instinct, Personal Ambition can create a Diversion. Instinct can then become a Common Sense expression of Personal Ambition.

Did Personal Entities manifest from an Instinctual Common Entity Mind? Has the personalised Passion of Personal Ambition become too important?

GOD MIND: Dreamscape

A GOD MIND is an Intuitive Mind. GOD is an acronym for Guidance Of Divinity. DIVINITY is an acronym for Direct Intuition Via Initial Nature In Total Yield.

Why would the Personalities of Unconsciousness develop a Belief, or many Beliefs, in a God or Gods? Is Intuition the unintentional perpetrator of those Beliefs?

A Personality manifests from Identity-interactive Attitudinal Feelings, which suggest an Identified Attitudinal behaviour or Nature. Identity is an interaction of Intellect, Motive, and Belief. It Intellectualises Beliefs, which means that it takes on board and builds upon declarations of Personal preferences or Choices.

We have already established that Intuition is Suggestive through Awareness, Belief, and Attitudinal Feeling. It creates and modulates Dreams. Intuitive Awareness is created and suggested by impressions of Desire, which are Personal Wishes. If a Personality experienced

Guidance in response to its Personal Wishes, sometimes voiced, that it could not explain or Understand, could it unintentionally manifest Dreams of Supernatural Entities via the Virtualisation abilities of focused Imagination? If related to a “Progressive Dissociation of Unconsciousness”, it would not only be possible, but probable. Eons of Virtualising those Beliefs, developing them into religious practices, and detailing them through a Habit or Comfort Conscience, could Actualise them into the Psyche of any Personality with the same Belief-mind. If a Personality had a Passionate Ambition to share those Actualised Beliefs, that Passion could influence many Personalities. Personalised Passion forms Personal Ambition.

The acronym of PASSION is Purpose Activated Sensual State Incurring Opulent Nirvana. It is a construct of Suggestive Awareness. A strong Personal Passion can influence the Awareness of many Personalities.

Attitudinal Feeling is a construct and Sensory expression of Emotional or Suggestive Intelligence. The Personalised Attitudinal Feeling of Intuition can influence the Emotional Intelligence of many Personalities because Attitudinal Feeling is open to Attitude suggestion, accessible through Attitude suggestion, and able to be built upon and improved by Attitude suggestion. Therefore, accepting unfounded Beliefs as Actual fact is not a sign that one lacks Intelligence. It can simply be a consequence of shared Feelings that can influence our Nature, which is our Attitudinal behaviour, or, initially, it can be a consequence of a lack of Awareness of our Unconscious Potential, which is a limited Consciousness of Unconsciousness.

Becoming more Conscious of our Unconscious Potential, and more Aware of what that means, is the best way to Understand the SELF, and therefore to reconstruct the Conscious or Personal reflections of the SELF.

TIME;

Thought-Intention-Motivation-Expression

Is there a Geometrical structure that represents TIME?

In Geometrical Thought Harmonics, Thought is represented as a Point. Intention, which has an agenda, is represented as an Angle formed between two ‘Lines of Thought’. A Line of Thought, which is a connection between two Points, is a Way of Thinking. A Trait, which is a design of Thought, is represented by a Polygon. Motive is Personal or Conscious Thought, and is represented by a Pentagon.

TIME is a process from Thought to Intention to Motivation, and then to Expression. It is an expression of Consciousness. Instinct is an expression of Personalised Common Sense agreements, forming Personalised Common Logic, and becomes an example of Physical Motivation or Physical Consciousness. It is a Personalised Common Library Of Growing Intelligent Concepts.

Intuition is an expression of Personalised Attitudes, Intellect-based Sense, in the form of Attitudinal Feeling, and becomes Intuitive Nature. Will is an expression of Motive-based Sense, a true Personal Sense, which is Desire. They are all Motive-oriented expressions of Sense, focused Creative Thought or Imagination, which label, recognise, and recall Personal and Personalised Memory.

Does an Icosahedron of Will represent TIME, or, does an Icosahedral system represent TIME? Instinct and Intuition are constructs of an Icosahedral system. Many Viruses, which are Thought Viruses, are products of an Icosahedral system. They are consequences of Will.

Is TIME a consequence of Will? If so, TIME could be a variable reliant upon the infrastructure of Will. What is an infrastructure of Will? A Virtual Brain-mind, Belief Mind, Identity Mind, Motive-oriented Awareness Mind, Motive-oriented Synchronicity Mind, and Motive-oriented Morality Mind are components of that infrastructure. They are all aspects of Consciousness, which is TIME-related.

Awareness would not be TIME-related unless it was Motive-oriented. Self-awareness and Passion, which are products of Emotional Awareness, would not be TIME-related unless they formed Compassion and Personal Ambition. Reason would not be TIME-related unless it

formed Justice. Empathy, which is a product of Reason and Nature, would not be TIME-related unless it formed Social Justice, which is a product of Intuition and Justice. Intuition is a construct of Emotional Awareness, Emotional Belief, and Emotional Intellect in the form of Attitudinal Feeling or Nature.

If TIME is variable, and it is Consciousness-related, how do we alter TIME? By altering Consciousness? If Consciousness is Will-related, would TIME alter through a manipulation of Will or any other Will-related structures such as Instinct and Intuition?

Faith is Trust-based Will. Could Faith alter TIME-related events due to its Suggestive Belief and Suggestive Intelligence in the form of Belief-based Feeling or Trust?

Instinctual Respect is a construct of Instinct that forms the Awareness-based Feeling of Respect. Could Instinctual Respect alter TIME-related events due to its Personalised Suggestive Awareness and Suggestive Intelligence?

Personal Memory, which is Chronological Memory, is TIME-related. It is temporary or changeable. Impersonal Memory is not. It would accumulate and be categorised without Chronological references. If this is correct, is there a different Memory bank for Personal or Conscious Memories? Is Consciousness a Partition, or an infinite number of Partitions, within the Unconscious Mind? Are those Partitions retained after a Personality ceases expression, or, are those Memories integrated into the Unconscious Mind by removing Chronological and Personal references?

Prayers to a God; Intuitive Wishes

What happens when we pray to a God? Where do those prayers end up? In other words, who or what receives those prayers?

Intuition is the receiver of Wishes. Intuitive Awareness is created and interpreted by impressions of Desire, which is a Personal Sense. The Impressions of Desire are internalised and interpreted Wishes, which create and suggest an Emotional Awareness of internalised and interpreted Personal Memories.

Instinct is a construct and expression of Common Sense agreements, which forms a Personalised Common Logic, a Library of Personalised Common Memory.

Expressions of Desire are externalised Wishes. Will is an externalised interpretation of Desire, which externalises interpreted Wishes or interpreted Personal Memories.

Intuitive Nature is a Sensory expression of Personalised Attitudinal Feelings, which suggest Personalised Attitudinal Behaviour. Feeling, which suggests behaviour, is an expression of Emotional/Suggestive Intellect or Intelligence. Intellect is receptive and constructive Thought. Attitude is Intellect-based Sense, which labels, recognises, and recalls Intellectual Memory. Attitudinal Feeling would express Intellectual Memory that was suggested and created by Emotional Intelligence. It would suggest Sensory Attitudinal behaviour.

Intuition connects all Life forms through suggestive Belief, suggestive Awareness, and suggestive behaviour. When prayers, which are Desires or Wishes, are internalised, all Life forms subconsciously receive those prayers through Intuitive Guidance. Those prayers would be answered subconsciously through the Intuitive Will of Personalities that are capable of fulfilling those Wishes. Intuition would Guide those Personalities through a subconscious suggestion of appropriate Sensory Attitudinal behaviour.

Prayers have always been received, and if possible answered, by the Conscious Personalities of an Unconscious Potential. It is always dependent upon the Awareness of those Personalities. If they have a higher Awareness of their Unconscious Potential, so-called miracles can be experienced.

Meditative Practises

What is Meditation? In general, meditation is focusing the Brain-mind or focusing our Thoughts upon a particular subject or object. Focusing the Brain-mind can mean preventing our Thoughts from wandering in unwanted directions. It can also mean, stopping the Brain-mind from responding to its environment. This entails being Aware of what is going on around us but not forming opinions from that sensory information or trying to analyse that information. However, it should still respond automatically to any actual threat, not perceived threat, while in that state of concentration. Oblivion may appear blissful, but living in a volatile environment while in a state of oblivion is only an attempted escape and not compatible with wellbeing. Meditation can be used as a temporary escape from a Conscious environment.

In essence, Thought is a response to or an opinion of an environment. It is initially an unconscious process. To stop that process, we must have conscious control of Thought, which is the potential to Think. This can be an arduous task for many practitioners. However, for some, it seems to come easily. Once achieved, the Brain-mind becomes still.

Why would we want the Brain-mind to become still? While Thinking, we are transmitting. If we wish to access information from memory, whether localised or universal, we must receive rather than transmit. If we respond to the memory being accessed, we then start transmitting rather than receiving. Therefore, the access is halted.

Focusing the Brain-mind on a particular subject or object can also access memory. This is a request for access, which is to make a wish. Desire, or a wish, is motive-based Sense, which is motive-based focused Creative Thought. Will is an expression of Desire and Intuitive Awareness is impressed by Desire.

Awareness is a conclusive Agreement of focused Creative Thought, which is a Love-based Sense Agreement. Love is unconditional acceptance, which creates programs and reflex responses. Sense, labels, recognises, and recalls memory. Intuitive Awareness, which is a Personalised or motive-regulated Suggestive or Emotional Awareness, requests memory according to impressed Desires or wishes. It makes personal or Conscious requests to the Universal or Unconscious Mind.

Intuition is also a product and expression of personalised or motive-regulated Nature, which is Attitudinal Feeling. This expresses personalised or motive-regulated Attitudinal behaviour. Attitude is the position a body takes in relation to an environment. It is an Intellect-based Sense, which labels, recognises, and recalls Intellect-based memory. Intellect takes on board and builds upon concepts. It is receptive and constructive Thought. Feeling is an expression of Emotional or Suggestive Intellect. Nature is an Attitudinal expression of Emotional or Suggestive Intellect, which is a physically creative expression of Emotional or Suggestive Intellect. It Physically creates and expresses Suggested behaviour. Intuitive Nature expresses personalised or motive-regulated Attitudinal behavioural memory in response to the impressed wishes or Desired Awareness of Intuition. This memory can be Personal, environmental, and universal. Intuition is the personalised guidance that connects all Mindstates within the Dream that is Mind.

Moving Meditation

Are so called normal meditative practises still relevant?

Life is movement, interaction, and response. Separating ourselves from that movement, interaction, and response does not help us to deal with reality. It simply allows us to escape temporarily from it when we find it difficult to cope. This is only necessary while learning to focus and calm the Brain-mind. Once learnt, we should take that skill with us in our normal lives. Remaining centred while interacting with our environment and conducting our normal activities allows us to become more Aware of what is going on around us. It also helps us to respond to that interaction with a balanced and more focused Mindstate.

Many would disagree with these statements. However, isolated meditative practises can become products of habitual or rigid Thinking. It seems rather contradictory to say that, because meditation is usually practised to free the Mind. Anything that gives us pleasure can eventually,

and usually without conscious recognition, become an illusionary comfort zone. Many practitioners have isolated themselves from reality to satisfy their need to free the Mind. However, Life is the Dream that is Mind. Therefore, freeing the Mind should be a process of becoming less restricted within the Dream of Life. Many would say that Life is an illusion and therefore we should separate ourselves from that illusion. However, practised forms of evacuation from the Dream of Life are the real illusion. Mind is the Dream of Pure Potential. Life is experiencing the Dream that is Mind. If we do not like the Dream that is Life, we should change the way we are Thinking and acting rather than finding better ways of shielding ourselves from what we have created!

Messianic Delusions

What is a Messiah? In commonly accepted terms, it could mean saviour or liberator. It usually has religious connotations. However, all previously acknowledged saviours or liberators fell short of public expectations and also the personally attributed expectations of the so-called saviour him/her self. In general, most of those historical individuals had well-meaning intentions. Little did they realise the consequences of those well-meaning intentions. Human nature, or Attitudinal behaviour, has infinite qualities. Whether those qualities are good, bad, or indifferent is relative to the perceiver. Perception is somewhere between Awareness and Morality, a conclusive agreement of imagination and experiential judgement. It is a form of understanding that is not due to Intellect, which is receptive and constructive Thought. Awareness is partly due to the interactive imagination and unconditional acceptance of Love. Morality is due to interactive intellect. Therefore, Perception does not appear to be creative, receptive and constructive, or experiential. It seems to be reactive rather than interactive. What is this all about? Throughout time, symbols have been associated with certain religious and political mindsets. A Star of David, which is two overlapping and interacting Equilateral Triangles, represents the interactive imagination or interactive creative thought of Love. A swastika represents an Intellectual revolution or an Intellectual agreement of direction. It could be perceived and presented as revolving clockwise or anticlockwise. In Geometrical Thought Harmonics, a Square represents Intellect and a centre-point Square represents an Intellect Agreement. An Equilateral Triangle represents Imagination or Creative Thought and a Hexagon represents Love. An Octagon, which is formed from two overlapping and interacting Squares of Intellect, represents Morality. Did the people using those symbols live up to or even recognise the intended meaning of those symbols?

The story of Jesus seems to infer that he wished to create Peace. The story of Buddha also infers the same intention. All of the pre-religious Human examples of Peace probably Thought in a similar way. I say pre-religious, because those individuals existed before the religions, doctrines, or movements were created in their names. Has Peace been created from those religions, doctrines, or movements? I think we all know the answer to that question. If those individuals were so influential, why didn't they bring Peace to at least their own cultural and political environments?

Where do we begin? It appears that great thinkers, and Peaceful Thinkers, were born into times of ignorance and violence to bring about awareness and knowledge. They all had followers who either revered them or recognised their higher potential. However, Human nature played an important role in how those individuals were perceived, and what could be done with their knowledge, after they passed away. Competitive ignorance played a major role in the outcome. Just because the originators of the new way of Thinking were Peaceful and Moral, does not mean that the followers could remain Peaceful and Moral after the influence had passed. In addition, in a world of people so fearful of each other's potential and so competitive to achieve their worldly goals, if the new way of thinking was not compatible with those goals, the intentions of the messiahs, sages, or new thinkers would have become distorted at the very least and completely lost at the worst.

I Feel for all of the Peaceful, progressive, and Moral thinkers of the past and present. They struggled to achieve a higher way of Being within an immoral and violent environment. Their examples were not enough to change the world for the better. However, it will not stop future individuals from trying.

HEAVEN

From where did we get concepts of Heaven? The acronym of HEAVEN stands for Highly Evolved And Vehemently Expressed Nuptials. Nuptials, in this regard, are a process of connection, relationship, or bonding. Therefore, a concept of Heaven would be a Passionate connection, relationship, or bond with Life and its many forms, with an Environment, or with what has been Consciously expressed from the Pure Potential of Unconsciousness.

“Heaven on Earth” is a popular wish. How would that come about? EARTH, as a Platonic solid in Sacred Geometry, was symbolised by a CUBE. In Geometrical Thought Harmonics, which is a Language of Thought, a Cube represents Common Logic, which is a Common Library Of Growing Intelligent Concepts. It is an accumulation and categorisation of Common Memory. We are able to form conclusions and problem solving abilities from Logic. However, Personal Logic is not necessarily a form of Common Logic. It can be an accumulation and categorisation of Personal preferences or choices. Those choices or personal preferences can differ from one Personality to the next. Competition between Personal preferences can form conflict.

Through Dissociation of Unconsciousness, many Gods have been imagined and adamantly defended. Personal or Motive Logic, Belief Logic, and Identity Logic could be the culprits. What we Identify with can give us Comfort, which can lead to Habitual behaviours and Comfort Zones. Religion has become a Comfort Zone for many Personalities of Consciousness. However, there is a multitude of differing religions. Therefore, through interaction and an unquestionable declaration of Personal preference, these religions can conflict.

In my Understanding, the only way to achieve a so-called Heaven on Earth is for all Personalities that have manifested from the Pure Potential of Unconsciousness to Understand how they came about, and what the Pure Potential of Unconsciousness is. It may seem like an impossible task, but Pure Potential is an infinite source of possibilities. Therefore, anything is possible. However, it is only probable when conditions and circumstances allow. While there is conflict between imagined and rigidly adhered to Beliefs, Hell on Earth is probably the only Logical result.

Our way of Thinking creates all conditions and circumstances. Open-mindedness and Unity Awareness are necessary to express the best probabilities. We are already experiencing the probabilities of Closedmindedness and Competition. It is time to make a better choice!
